NOVEMBER 1991, THE BONNIE #4 LODE MINING CLAIM UNDER AND PURSUANT TO THE MINING  
LAWS OF THE UNITED STATES AND THE STATE OF NEVADA. SAID CLAIM IS LOCATED UPON A  
VALUABLE MINERAL DEPOSIT CONTAINING LIGHT WEIGHT MATERIALS AND OTHER LOCATABLE

BEGINNING AT THE SW CORNER NO. 1 OF THIS CLAIM, THENCE DUE NORTH,  
A DISTANCE OF 1500 FEET TO THE NW CORNER NO. 3, THENCE DUE EAST,  
A DISTANCE OF 600 FEET TO THE NE CORNER NO. 4, THENCE DUE SOUTH,  
A DISTANCE OF 1500 FEET TO THE SE CORNER NO. 6, THENCE DUE WEST,  
A DISTANCE OF 600 FEET TO THE POINT OF BEGINNING.

RECORDED IN BOOK 92, PAGE 487, OFFICIAL RECORDS OF LINCOLN COUNTY, NEVADA.


