CERTIFICATE OF LOCATION  
NEVADA

KNOW ALL MEN BY THESE PRESENTS, THAT GOLD FIELDS MINING COMPANY, whose current mailing address is 1687 Cole Boulevard, Golden, Colorado 80401-3301, by its Agent, the undersigned, hereby locates the DVH 16 Lode Mining Claim on the 6 day of October, 1991, situated in the Unknown Mining District, Lincoln County, Nevada, and by this Certificate, and by right of discovery and location, claim 1500 feet, linear and horizontal measurement, along the vein thereof, said vein running 25 feet in a South direction from the point of discovery and 1475 feet in a North direction from the point of discovery, together with 300 feet on either side of the middle of said vein at the surface. The discovery monument on which Notice of Location is posted is located at said point of discovery.

The general course of this lode or vein is North and South.

The Claim is located in the NE1 and NW1 of Section 18 and SE1 and SW1 of Section 7, Township 1 North, Range 66 East, Mount Diablo Meridian, Lincoln County, State of Nevada, and more particularly described by metes and bounds as follows:

Beginning at Corner No. 1 which is the Northeast corner of this mining claim, thence South a distance of 750 feet to the East Side Center; thence South a distance of 750 feet to Corner No. 2 which is the Southeast corner of this mining claim; thence West a distance of 600 feet to Corner No. 3 which is the Southwest corner of this mining claim; thence North a distance of 750 feet to the West Side Center; thence North a distance of 750 feet to Corner No. 4 which is the Northwest corner of this mining claim; thence East a distance of 600 feet to Corner No. 1, the point of beginning.

Claim boundaries are monumented by 4" X 4" X 4' wood posts set one foot in the ground, one at each corner of the claim and one at the center of each side line. Each corner contains markings sufficient to appropriately designate it as a corner of said claim.

Beginning at Corner No. 1 which is the Northeast Corner of this claim, thence a distance of 5900 feet South and 300 feet West to the following natural object or permanent monument, to wit: the South 1/4 corner, Section 18, Township 1 North, Range 66 East, Mount Diablo Meridian, State of Nevada.
