

Certificate of Location of Lode Mining Claim

The claim is 1200 feet long and 300 feet wide, and 25 feet is claimed in a north direction and 250 feet in a south direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 600 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the west to the east.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by indelible ink on PVC pipe

- Corner No. 1 is a 4" x 4' PVC pipe labeled NWC

- Corner No. 4 is a 4" x 4' PVC pipe labeled SEC
- Corner No. 5 is a 4" x 4' PVC pipe labeled SSC
- Corner No. 6 is a 4" x 4' PVC pipe labeled SEC

The monumentation and marking of the corners was completed by the 14 day of March, 1992.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
