The general course of the lode deposit and premises is from the NORTHLY to the SOUTHLY.

Corner No. 6 is a WOODEN POST 4x4, LOST A.V. #3 N. COR. STAMPED

The monumentation and marking of the corners was completed by the 19th day of MAR, 1992.
