ITEM I

I do solemnly swear that I promise to marry CAROLYN SUE ROWLES on or about April 10th, 1992 and to be faithful to her only.

ITEM II

I do solemnly swear that I will not commit any acts of adultery with anyone from this day forward so as not to injure CAROLYN SUE ROWLES emotionally, morally, or sexually. I further state she does not need any legal proof of my committing such an act.

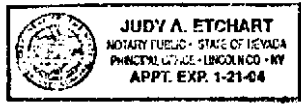
