THE affiant Collon C. Kennedy does hereby swear and affirm under the penalty of perjury that the assertions contained in this Affidavit are true and correct.

THAT he is of the age of majority and is a citizen of the United States of America.

THAT he is the Land Manager and Assistant General Counsel - Exploration for Gold Fields Mining Company, a division of Hanson Natural Resources Company ("Gold Fields"), a Delaware general partnership qualified to do business in the State of Nevada, with a mailing address of 1687 Cole Boulevard, Golden, Colorado 80401-3301, and he is Gold Fields' authorized agent for the purpose of submitting this Affidavit of Labor or Improvements.

THAT the mining claims which are the subject of this Affidavit (individually and collectively, "Claims") are located in Lincoln County, Nevada and are named in Exhibit "A", attached hereto and made a part hereof, and are described therein by reference to the BLM N MC serial numbers assigned to each of the Claims and the book and page in the Lincoln County Clerk and Recorder's Office in which the Certificate of Location for each of the Claims is filed.

THAT the sections, townships, ranges, and meridian of the United States survey, or if unsurveyed, by projected and protracted survey lines from such United States survey, within which all or any part of each of the Claims are located, are described in Exhibit "A".

THAT the Claims comprise a group of contiguous mining claims which were held by Gold Fields by right of location or lease.

THAT during the assessment year commencing at 12 o'clock meridian on the 1st day of September, 1991 and ending at 12 o'clock meridian on the 1st day of September, 1992, money was expended for labor performed or improvements made on the mining claims that are described in Exhibit "B" (attached hereto and made a part hereof).
