CERTIFICATE OF APPROPRIATION OF WATER

WHEREAS, Frank C. Hulse, Agent has presented to the State Engineer of the State of Nevada Proof of Application of Water to Beneficial Use, from an Underground Source through a drilled well, pump and distribution system for Irrigation and Domestic purposes. The point of diversion of water from the source is as follows:

NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 21, T.7S., R.61E., M.D.B.&M.
or at a point from which the NE corner of said
Section 21 bears N. 71° E., a distance of
1758.05 feet situated in Lincoln County, State
of Nevada.

NOW KNOW YE, That the State Engineer, under the provisions of NRS 533.425, has determined the date, source, purpose, amount of appropriation, and the place where such water is appurtenant, as follows:

*The total combined rate of diversion and duty of water under any certificate issued under Permits 45759 and 52013 is limited to 0.40 c.f.s. and 289.59 acre-feet annually, respectively.

**The total combined duty of water under Proof 01630 (Pahranaagat Lake Decree) and any certificates issued under Permit 45759 and 52013 is limited to 473.99 acre-feet annually.

***This certificate changes the point of diversion of Permit 45760, therefore, the date of priority remains the same as Permit 45760.

This certificate is issued subject to the terms of the permit and with the understanding that the total duty of water shall not exceed 5.0 acre-feet per acre per annum from any/or all sources.

The right to water hereby determined is limited to the amount which can be beneficially used, not to exceed the amount above specified, and the use is restricted to the place and for the purpose as set forth herein.
