DECLARATION OF TRUST

This TRUST shall be of the type known as a REVOCABLE TRUST and shall be administered by the GRANTOR TRUSTEE until his death or until the GRANTOR is legally incapacitated and unable to administer said TRUST at which time a SUCCESSOR TRUSTEE will administer this TRUST or appoint a SURVIVING TRUSTEE.

NAME and DOMICILE

This TRUST SHALL be domiciled in and shall be interpreted and construed under the laws of Nevada the State of.

DECLARATION of the Robert F. Hamblin TRUST.

hereby establish, The Robert F Hamblin TRUST, naming myself as TRUSTEE of this GRANTOR or REVOCABLE TRUST as the creator thereof; and I declare that I hold and will hold assets and properties hereinafter named for the use and benefit of the BENEFICIARIES hereinafter named, and that I hold these assets and properties not as tenants in common or as community property, but as joint tenants with rights of survivorship such assets and properties to be disposed of and distributed following the death of the TRUSTEE-GRANTOR named above according to the terms of the TRUST.

3. I hereby appoint Edwin Dean Hamblin to serve as SUCCESSOR TRUSTEE following the death of myself, GRANTOR/TRUSTEE.
4. Should the SUCCESSOR TRUSTEE, for any reason, be unable to serve, I hereby appoint Robert Russell Hamblin to serve as CONTINGENT SUCCESSOR TRUSTEE.
5. Upon the death of the original TRUSTEE, the SUCCESSOR TRUSTEE is hereby directed to assume the duties and powers of TRUSTEE and to Transfer forthwith the assets and properties of this Trust to the Beneficiaries herein named, in accordance with the provisions of this Indenture.
6. I hereby direct that whenever the corpus of this Trust shall have been fully distributed, this Trust shall be dissolved and terminated.
7. I reserve the right during the lifetime of the TRUSTEE/GRANTOR to amend or revoke this Trust in whole or in part without consulting or obtaining consent of any Beneficiary named herein; however any such amendment or revocation shall be duly recorded in the Office of the County Recorder. Should I decide to sell or liquidate any of the assets of this Trust, I reserve the right to make whatever disposal of any receipts received therefor, in whatever manner I desire.
8. I reserve the right to designate a new Beneficiary or to remove any existing Beneficiary at any time during my lifetime.
9. In the event of legal incapacity, I hereby appoint the SUCCESSOR TRUSTEE named above as the person to assume the duties and powers of acting TRUSTEE hereunder. The SUCCESSOR TRUSTEE is hereby directed to use all income and assets necessary for the complete care and comfort of the GRANTOR.
10. No Bond shall be required from any TRUSTEE or SUCCESSOR TRUSTEE.
11. Since this is a common law Trust, it shall be enforced and administered without the permission or interposition of any Court or other person or authority.
12. This Declaration of Trust shall extend to and be binding upon the Heirs, Executors, Administrators, and Assign of the undersigned.
13. This Declaration of Trust shall be construed and enforced, wherever applicable with the laws of the State of NEVADA.
