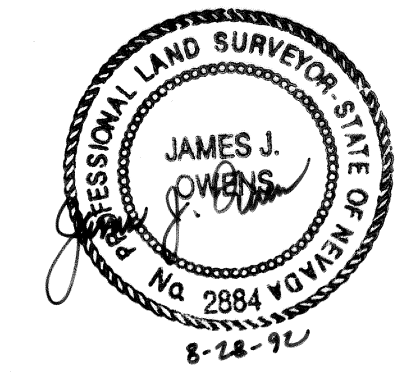


SURVEYOR'S CERTIFICATE

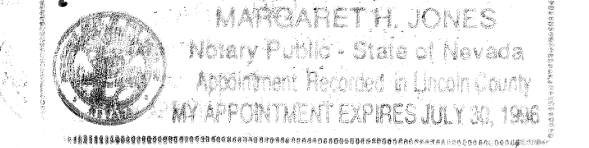

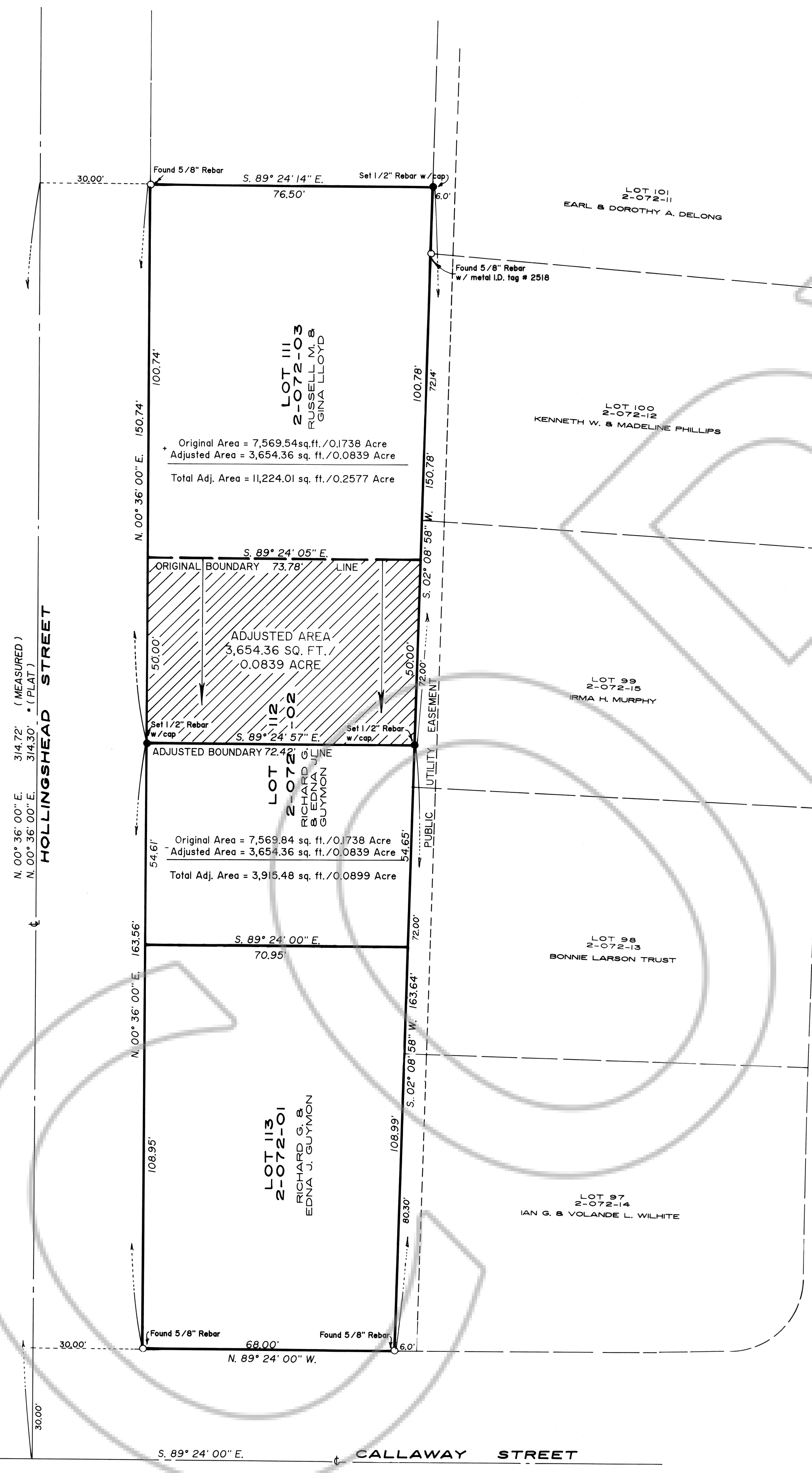

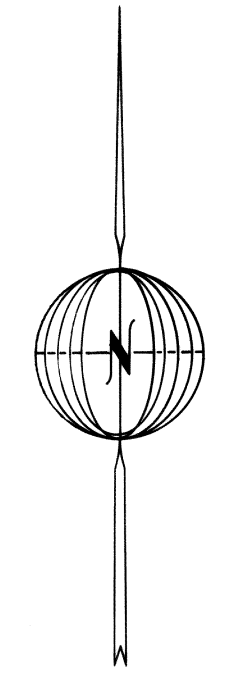


LEGAL DESCRIPTION OF ADJUSTED AREA

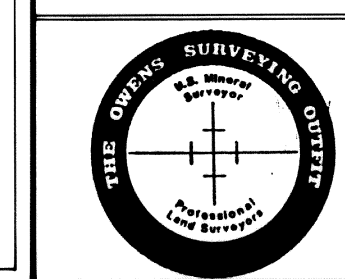
- 1. Subdivision Plat - Sun Gold Manor Unit No.1 - Reception No. 27842 - Sept. 30, 1952.
