
The owner of the Mine Property in whose behalf and at whose expense the work was performed is the Prince Company.

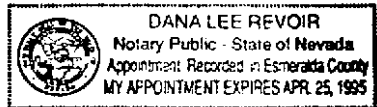
