

DECLARATION OF HOMESTEAD

JOSEPH DeCARLO and EVELYN MAE DeCARLO, do hereby certify and declare as follows:

1. That we are married and husband and wife;
2. That we are head of the household, and presently residing on the land and premises herein described.

3. That we presently reside at

4. That we claim the following land and premises located in the City of Panaca, County of Lincoln, State of Nevada, and more particularly described as follows:

"A part of what is known as the Southeast corner of the Southeast Quarter of Section 5, T.2 S., R. 68 E., M.D.B.&M., and commencing at the Northeast corner of what is known as the A. O. Lee Lot No. 3 in Block 19, thence in a Northerly direction along the street line 120 feet; thence at right angles with street line 32 rods in a westerly direction to the street line; thence along street line 120 feet in a southerly direction and thence at right angles with street line 32 rods in an easterly direction to the place of beginning. Said strip of land being the southerly 120 feet of lots 1 and 2 in Block 19 in the town of Panaca, Lincoln County, Nevada; save and except the northerly 50 feet of the described property which is owned by RONALD J. PALMER and MYRNA L. PALMER.

Together with one share of water in the Panaca Irrigation Company, and all buildings and improvements situate on said land.

TOGETHER with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the reversions, remainders, rents, issues and profit thereof."

5. We claim the land and premises hereinabove

described, together with the dwelling house thereon, and its appurtenances, as a Homestead.

6. We estimate the actual cash value of the land and premises hereinabove described to be \$ 23,391.00

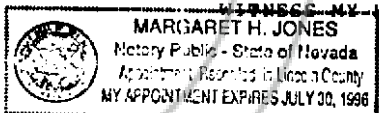
