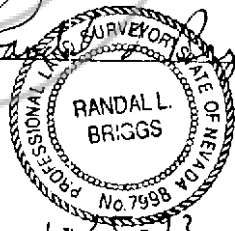
As erected, buried 1 foot in the ground and being securely capped. The corner's are marked as described above by a aluminum tag.
