The claim is approximately 1500 feet long and 600 feet wide, such that 1490 feet is claimed in a Westerly direction and 10 feet in a Easterly direction from the point of discovery, at which the notice of location was posted, together with 300 feet on each side of the Monument of Location. The general course of the lode is from the East to a Westerly direction.

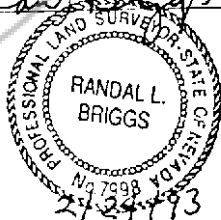
As erected, buried 1 foot in the ground and being securely capped. The corner's are marked as described above by a aluminum tag.
