**SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS**

THIS DEED OF TRUST, made this March 1993 day of March 1993, between Earl C. CORP. herein called TRUSTEE,

WITNESSETH: That Trustor IRREVOCABLY GRANTS, TRANSFERS AND ASSIGNS TO TRUSTEE IN TRUST,

WITH POWER OF SALE, that property in Lincoln County, Nevada described as:

The East ( E 1/2 ), and the East Half ( E 1/2 ) of the West Half ( W 1/2 ) of section 24, and The East Half ( E 1/2 ) of the northwest Quarter ( NE 1/4 ) of section 25 All in Township 11 South, Range 62 East, M.D.B.&M. Lincoln County, Nev. APN: 08-201-02

TOGETHER WITH the rents, issues and profits thereof, SUBJECT, HOWEVER, to the right, power and authority given to and conferred upon Beneficiary by paragraph (10) of the provisions incorporated herein by reference to collect and apply such rents, issues and profits.

FOR THE PURPOSE OF SECURING: 1. Performance of each agreement of Trustor incorporated by reference or contained herein. 2. Payment of the indebtedness evidenced by one promissory note of even date herewith, and any extension or renewal thereof, in the principal sum of \$ 300,000.00, executed by Trustor in favor of Beneficiary or order. 3. Payment of such additional sums as may hereafter be borrowed from beneficiary by the then record owner of said property, when evidenced by another promissory note (or notes) receiving it is so secured.

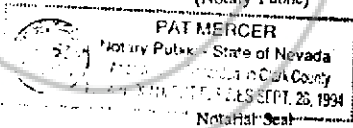
