

QUITCLAIM DEED

THIS INDENTURE made and entered into this 22nd day of June, 1993, between UMETCO MINERALS CORPORATION, a Delaware corporation, hereinafter referred to as Grantor, and NORTH TEMPIUTE MINING AND DEVELOPMENT COMPANY, a Nevada corporation, hereinafter referred to as Grantee:

NOW, THEREFORE, the said above-named Grantor for the purpose of terminating the said lease of the lands hereinafter described, does by these presents remise, release and forever quitclaim unto the said Grantee and to their heirs, executors, administrators and assigns forever, all its interest in and to the following unpatented lode mining claims situate in Lincoln County, Nevada, more particularly described as follows:
