I am not an entity subject to service of process of a State "Peace Officer #P039" or a State Court, when the Court's or the Officer's venue is within a legislative Regional District.



I, Lance Dee Ferwerda, In propria persona, Sui Juris, an absolute free white male American and State citizen, in the original sense, do hereby state and affirm the following facts:

1. My full name is Lance Dee Ferwerda; and,
2. I was natural born on Oct. 26, 1963, in the Republic of Washington; and,
3. I am a free white male citizen in the County of Sanpete, in the State of Utah, as evidenced by the "Public Notice - Positive Identification of Lance Dee Ferwerda," which is a matter of public record in the White Pine County Recorders Office, located at WHITE PINE COUNTY RECORDER'S OFFICE, in the County of White Pine, in the State of Nevada, recorded as number book 219 page 426, incorporated herein by this reference as if fully set out herein; and,
4. I have made my permanent place of abode in the State of Utah since 1965 and have made the County of Sanpete my permanent place of abode, and therefore as a citizen but not a resident therein; and,
5. I am not a Federal Citizen by virtue of the Fourteenth Amendment; and,
6. I specifically declare that my place of abode is: Sixth Judicial District, 1/2 mile west, Gunnison Res. Rd., in Sanpete County, in the State of Utah; and,
7. I never knowingly applied for or became a corporation, and officer or employee of a corporation, nor knowingly ever applied for or acquired an artificial alter ego (character) from any State, from the United States, or from the District of Columbia, its territories or insular possessions, or any agency created or regulated by the statutes thereof; and,
8. I never knowingly or willfully applied for or received any privilege from any agency of any state, the United States, or the District of Columbia, its territories or insular possessions, or any agency created or regulated by the statutes thereof; and,
9. I am not a member of the armed forces; and,
10. I have no account with the Utah State Tax Commission, the Utah Department of Transportation or its Motor Vehicles Division, or the Social Security Administration or their affiliates; and,
11. I am not now, nor have I ever, knowingly entered into any personal internal or private agreement, contract, stipulation, account or similar contrivance with any state, the United States, the District of Columbia, their territories, agencies, assigns or affiliates, or other property appertaining thereto; and,
12. I am not now, nor have I ever knowingly been, actually or constructively, a resident, citizen, subject or inhabitant of the District of Columbia, its subordinate territories, or property appertaining thereto, in either a legal or factual sense; and,
13. On or about Nov. 4, 1993, Officer I.D. #P039 in the pretended capacity of a statutory "Peace Officer," pretended to issue Utah Uniform Citation number C266255 and pretended service of a statutory summons in relation thereto, upon me, without authority of his official capacity and without authority of the legislative power and statutes under pretense of which said acts were committed, a true and correct copy of which pretended Uniform Citation summons is attached hereto, marked exhibit A; and,
14. No legitimate service of process can be made or has been made upon me in relation to the Uniform Citation mentioned in paragraph thirteen above; and,

15. I have not and will not enter a plea to the accusations pretended against me in the Uniform Citation, mentioned in paragraph thirteen above, in any statutory proceedings pretended thereupon; and,

16. I hereby formally withdraw any plea that any court may have entered or may enter, regarding the Uniform Citation mentioned in paragraph thirteen above; and,

17. I specifically deny any and all power of attorney, agency or similar power to the pretended plaintiff, pretended plaintiff's attorneys, and any court taking cognizance in this matter; and,

18. I specifically declare void any and all acts and/or omissions of said persons in paragraph seventeen above which purport to be in my behalf; and,

19. After full consideration of the facts evidenced herein, I have determined the accusations are merely pretended against me in the instant Uniform Citation which is defective and that I am not and cannot lawfully be brought withip the statutory venue of any court taking cognizance of said accusations without my voluntary appearance, therefore, as a matter of sustaining my assertion to defects in venue and jurisdiction, I will not voluntarily appear, or plead to the accusations, or be any action of my own legitimize the fraudulent process set out in Exhibit A attached hereto; and,

20. I never at any time, nor will I knowingly or willingly wave or otherwise relinquish my God given (unalienable) Rights, especially, but not limited to those which are secured at law under the Constitution of the United States of America (1787) and the Constitution of Utah 1896, and I specifically deny any waiver of said Rights made for me on my behalf by any agency of the State, the United States, the District of Columbia, its insular possessions or territories, or their affiliates or assigns whomsoever; and,

21. Therefore, I find there are two alternatives for the State of Utah to follow: to dismiss all past and present charges, warrants, fines, suspensions and any and all other similar actions which may be contemplated against me in the interest of justice; and,


22. Bring any future accusations or future actions against me in a CERTIFIED COURT OF COMMON LAW JUDICIAL VENUE AND JURISDICTION; and,

This affidavit is made in good faith and is intended to establish my place of abode under the venue established by the Organic Law of the United States of America and the State of Utah, to maintain, and to assist in retaining, the sovereignty of "WE THE PEOPLE" in State of Utah against the encroachment of the legislative municipal powers of the United States Congress, exercised by their regional agents; and,


