## PARTIAL RELEASE OF LIEN

Beginning at the southeast corner of Lot Three (3) in Block Thirty-Six (36) in the Town of Alamo, County of Lincoln, State of Nevada; running thence north 150'; thence west 147.5'; thence south 150'; thence east 147.5' to the point of beginning; together with any and all improvements situate thereon.

THIS RELEASE is made by the Government and accepted by the Corporation of the express condition that it shall not in any way affect or impair the liens and security of the Security Instruments, or any of them upon other premises and properties now subject thereto and not expressly released hereby. This release is made and accepted without covenant or warranty, express or implied at law or in equity, and without recourse to the Government in any event or in any contingency.
