LIMITED POWER OF ATTORNEY

NEEREAS, the Resolution Trust Corporation, a corporation duly organized and existing under an act of Congress of the United States of America, acting in its capacity as Conservator or Receiver of the institutions listed on Exhibit "A" attached hereto ("RTC"), is the owner of the loans (the "Loans") of such institutions; and

MERICAS, RTC desires to designate ARA CANIRAS, Vice President of J.I. Rislak Mortgage Corporation, a corporation organized and existing under the laws of Florida ("Servicer") as its true and lawful attorney-in-fact, in its name, place, and stead, and for its benefit in connection with Loans serviced by Servicer, for the purposes of performing all acts and executing all documents in the name of RTC necessary and incidental to servicing said Loans.

MOM, THEREFORE, RTC appoints Servicer as RTC's true and lawful attorney—infact to act in its name, place and stead, and subject to the further provisions herein, grants Servicer the authority, subject to the limitations herein, as follows:

- 1. To accept money due or to become due from borrowers and to collect past due amounts;
- To take those acts necessary to comply with regulations and requirements of the United States Department of Veterans Affairs, the United States Department of Housing and Urban Development, and any other Governmental entity or state or federal law;
- 3. To demand, recover, collect, receive, and receipt for all sums of money, checks, accounts, interests, dividends and demands due or owing to RTC, in connection with the Loans and to take possession of any collateral, and to inquidate that collateral by any lawful means and to take such lawful action as may be necessary, in the name of RTC, for recovery thereof by suit, garnishment, attachment, foreclosure, or otherwise.
- 4. To take any and all action necessary, on behalf of RTC, to file and process claims and accept claim proceeds from sortgage insurance or loan guarantee claims paid under the National Housing Act of 1949 or Chapter 37 of Title 38 of the United States Code and to endorse to the order of Servicer any checks which are made payable to RTC in connection with said Loans;
- 5. To take any and all action necessary to initiate, give notice of, and conduct foreclosure sales ("Foreclosures") on behalf of RTC, pursuant to any deeds of trust, mortgages or other sacurity instruments, accept deeds in lieu of foreclosure or otherwise acquire title to mortgaged properties, and the execution of any instrument necessary to accomplish the foregoing.

To sell, transfer, or otherwise dispose of real property acquired through foreclosure or otherwise and execute all contracts, agreements, deeds, assignments and other instruments necessary to effect any such sale, transfer or disposition and to receive proceeds checks made payable to the order of Servicer or RTC; and to assign the right to any deficiency judgment and or deficiency claim incident to a foreclosure or defaulted loan;
- To prepare, execute and deliver satisfactions, cancellations, discharges, or full or partial releases of lien; enter into and execute assumption agreements; and appoint substitute trustees;
- 8. To endorse promissory notes from RTC to Servicer, and execute assignments from RTC to Servicer of mortgages, deeds of trust, deeds to secure debt, and other security instruments securing said promissory notes;
- 9. To prepare, execute, and deliver any and all documents necessary to accomplish the foregoing, including but not limited to deeds, contracts, leases, assignments, bills of sale, releases, extensions, satisfactions, and full or partial releases of liens, and to take any and all such other acts of any kind and nature whatsoever Servicer may find necessary to service the Loans.

RTC further grants to Servicer full power and authority to do and perform all acts necessary to carry into effect the powers granted by or under this limited power of attorney as fully as RTC might or could do with the same validity as if all and every such act had been herein particularly stated, expressed, and especially provided for, and hereby ratifies and confirms that the Servicer shall lawfully do or cause to be done by virtue of the powers and authority granted and contemplated hereby.

The authority granted hereunder is limited to transactions where the book value of the subject asset or the obligation incurred with respect to the subject asset does not exceed \$1,000,000.00.

This Power of Attorney (the "Power") shall be effective as of the execution date and shall continue in full force and effect until June 15, 1996, (the "Termination Date") unless otherwise terminated in writing by the execution and delivery of an instrument revoking the authority hereby granted (the "Revocation").

Any third party may rely upon this document as evidence of Servicer's authority to continue to exercise the Powers until the Termination Date, unless a Revocation has been recorded in the public records of the County of Orange, California, or unless such third party has received actual notice of a Revocation Revocation.




