Provided that the Servicer, in complying with this Power of Attorney, shall be subject to, act in accordance with, and shall conform with the requirements of the applicable insuring or guaranteeing agency and with reasonable standards, procedures, methods, and practices generally observed and applied by permanent investors in mortgages comparable to those serviced by FMB, or as shall be reasonably requested by FMB, and shall establish and maintain books, files and accounting records in accordance with all the foregoing, which shall be the property of FMB, and which shall be accessible to FMB, its agents or regulators upon request, and shall otherwise conduct its activities consistent with, and in accordance with, that certain Servicing Agreement between FMB and the Servicer dated March 1, 1993.


