 mortgagor.S agree... to pay the deficiency.

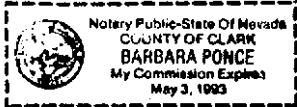

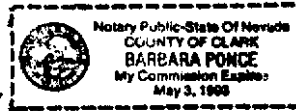
