 6 of Nevada:


7 Transferors, in consideration of Ten Dollars (\$10.00),

 13 follows:


14 Lots 8, 9, 10, 11, 12, 13, 14, 15, 16, 55, 56,

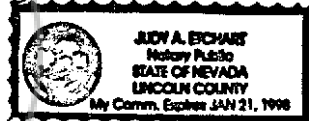
