THIS DEED OF TRUST, made this 1st day of April, 1994
between Russell D. Thomas and Floyd E. Thomas, husband and wife

whose mailing address is 4809 Stillwater Ave., Las Vegas, NV 89110, herein called GRANTOR or TRUSTOR,

LAND TITLE OF NEVADA INC. a NEVADA corporation, herein called Trustee, and

NEVADA BANK & TRUST COMPANY

WITNESSETH, THAT WHEREAS Trustee has borrowed and received from Beneficiary in lawful money of the United States the sum of \$21,763.08, TWENTY-ONE THOUSAND SEVEN HUNDRED FORTY-THREE AND 08/100 DOLLARS, and has agreed to repay the same, with interest, to Beneficiary in lawful money of the United States according to the terms of a promissory note of even date hereinafter executed and delivered thereto by Trustee;

NOW, THEREFORE, for the purpose of securing such agreement of the Trustee herein contained including payment of the said promissory note and of any money with interest thereon that may be advanced by or otherwise become due to Trustee or Beneficiary under the provisions hereof and for the purpose of securing payment of such additional sums as may hereafter be advanced for the amount of Trustee by Beneficiary with interest thereon, TRUSTOR irrevocably GRANTS AND TRANSFERS TO TRUSTEE, IN TRUST WITH POWER OF SALE, all that property in Lincoln County,

Situate in the County of Lincoln, State of Nevada, described as follows:

Lot Eleven (11) in the ROWAN SUBDIVISION in the City of Caliente, County of Lincoln
State of Nevada.

TOGETHER WITH all appurtenances in which Trustee has any interest, including water rights benefiting said realty whether represented by shares of a company or otherwise; and
TRUSTEE ALSO ASSIGNS to Beneficiary all rents, issues and profits of said realty, reserving the right to collect and use the same except during nonpayment of any party hereunder.

TO HAVE AND TO HOLD said property upon and subject to the trusts and agreements herein set forth and incorporated herein by reference. The following covenants, Nos. 1, 2, 3, 4, 5, 6, 7, 8 and 9 of NBS 102.030 are hereby adopted and made a part of this deed of trust, EXCEPT ONLY that the amounts agreed upon by the parties in this instrument with respect to covenants Nos. 4, 6 and 7 incorporated by reference of said trust and agreements is respectively as follows: Covenant No. 4, \$20,000.00; Covenant No. 6, Variation; Covenant No. 7, 20%. Such provisions so incorporated shall have the same force and effect as though specifically set forth and incorporated verbatim in this deed of trust.


