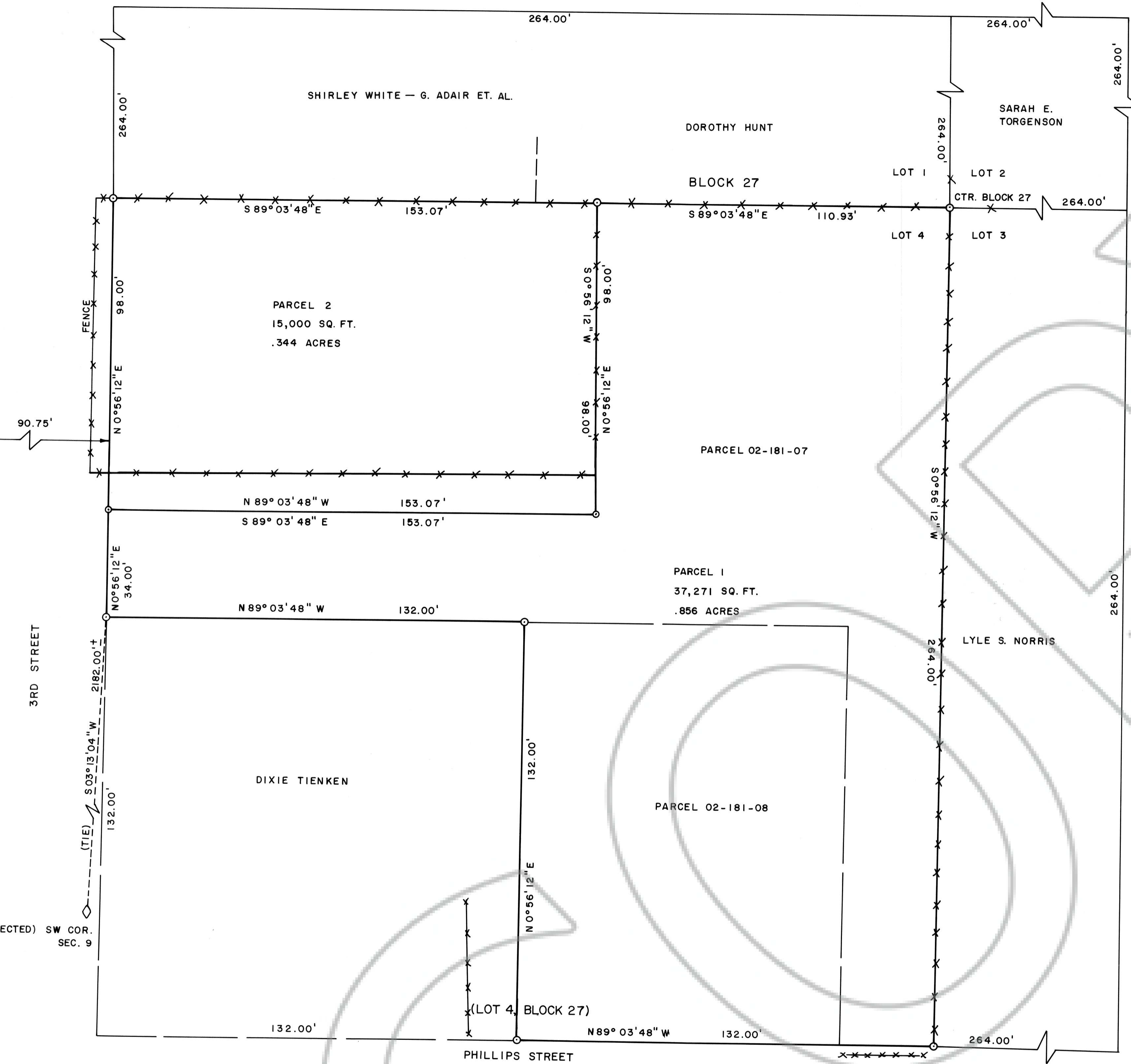
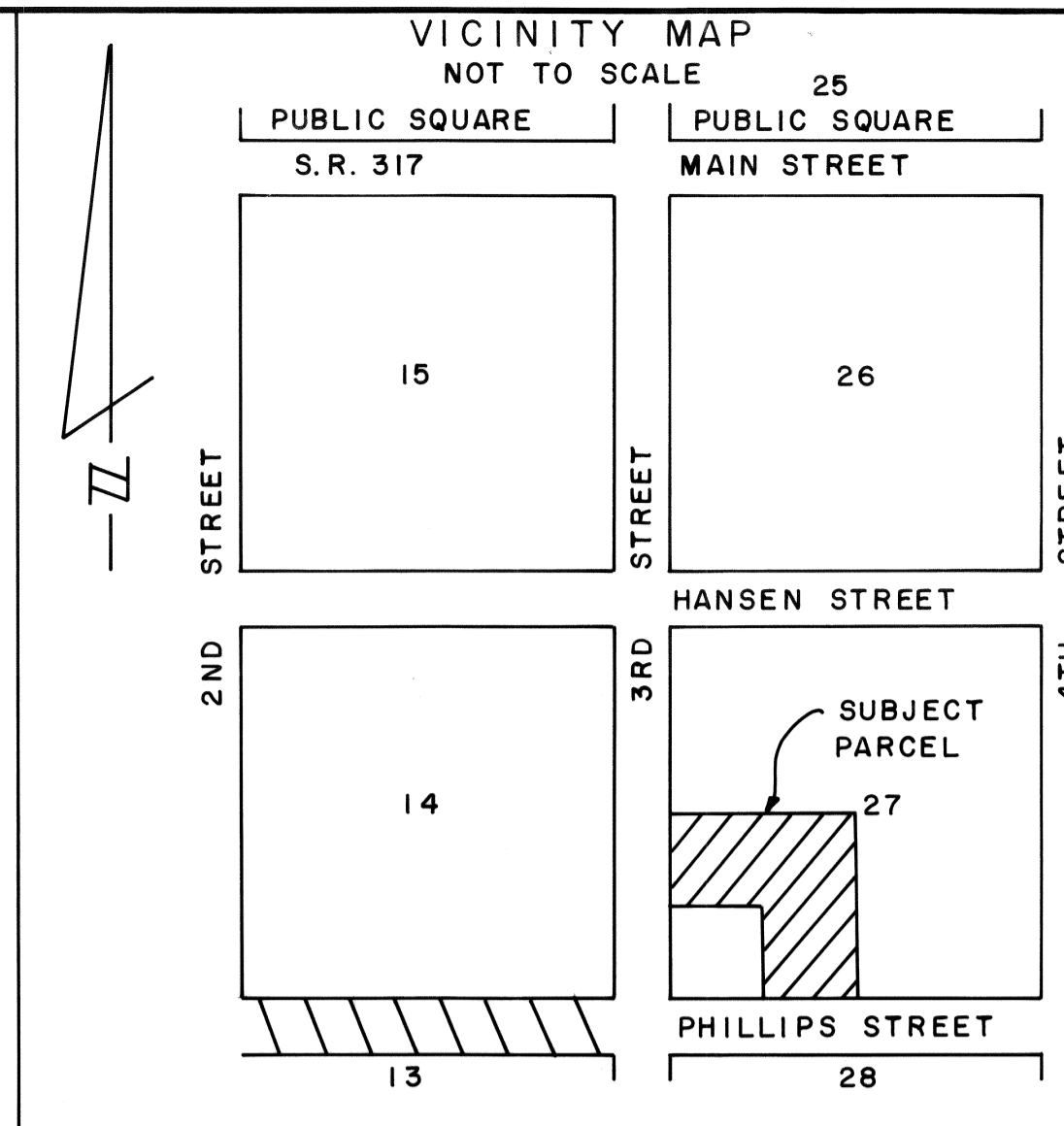


A PORTION OF THE NW1/4 NW1/4 SW1/4 SECTION 9, T2S, R68E, M.D.M.

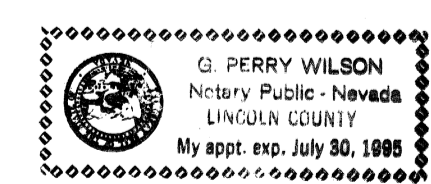

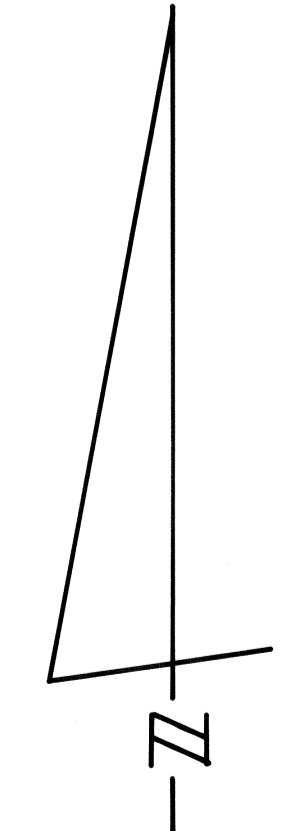
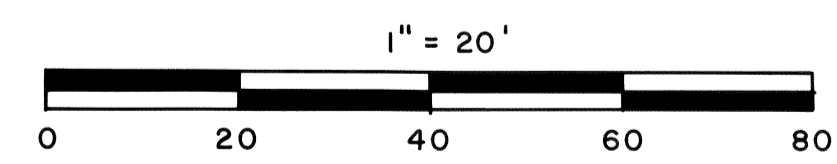
