## EXECUTOR'S DEED

## WITNESSETH:

That Grantor, by virtue of the Amended Order Approving First and Final Account, Petition for Distribution, to Fix Attorney's Fees and for Discharge, made and entered by the SEVENTH JUDICIAL DISTRICT COURT of the STATE OF NEVADA, in and for the COUNTY OF LINCOLN, in the case entitled "IN THE MATTER OF THE ESTATE OF DELLA W. WILKIN, DECEASED", being Case No. 1276, and in consideration of the sum of Ten Dollars (\$10.00) lawful money of the United States of America, to him in hand paid by the Grantee, the receipt whereof is hereby expressly acknowledged, does hereby grant and convey unto said Grantees and to their heirs and assigns forever, all right, title and interest of Decedent at the time of her death, and interest that the Estate may have subsequently acquired by operation of law, or otherwise, in and to that certain real property situate in the County of Lincoln, State of Nevada and more particularly described as follows:

3.030-26 A. Parcel No. 1: A parcel of land, situated in the NE1/4 of Section 2, T.3 S., R.67 E., M.D.B.& M., bounded and described as follows:

Beginning at the NW corner of the NE1/4 of said Section 2, and running thence due East 1660 feet, thence S.27° 02' East 1120 feet, thence due West 1155 feet thence due North 990 feet to the place of beginning, excepting and reserving therefrom right-of-way for Highway 93.

/2-230.07 Parcel No. 2: A strip of land across the Southerly portion of part of the SE1/4 of Section 35, T.2 S., R.67 E., M.D.B.& M., bounded and described as follows:

Beginning at the SW corner of said SE1/4 of Section 35, and running thence North 31 feet, thence Southeasterly to
