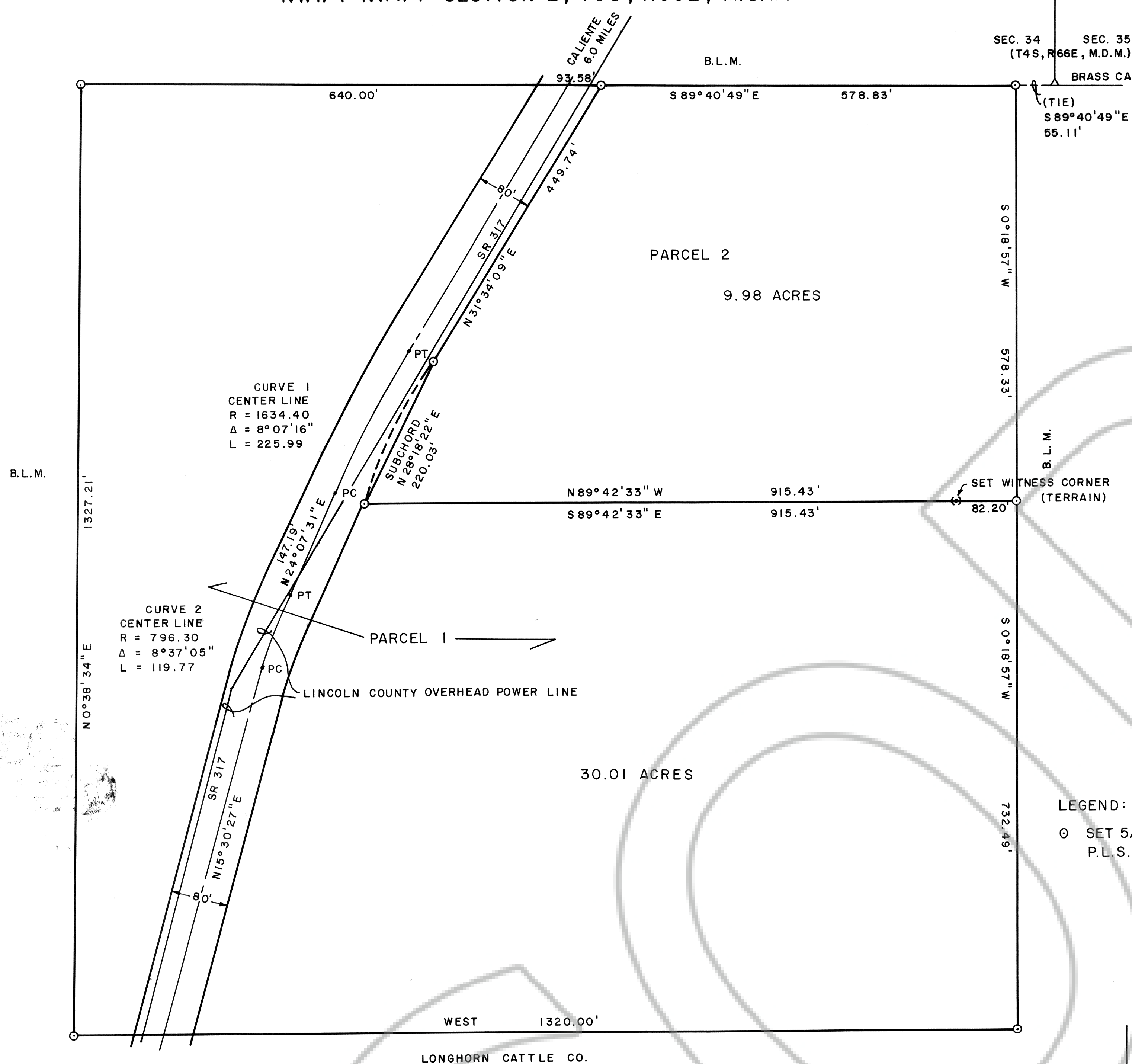

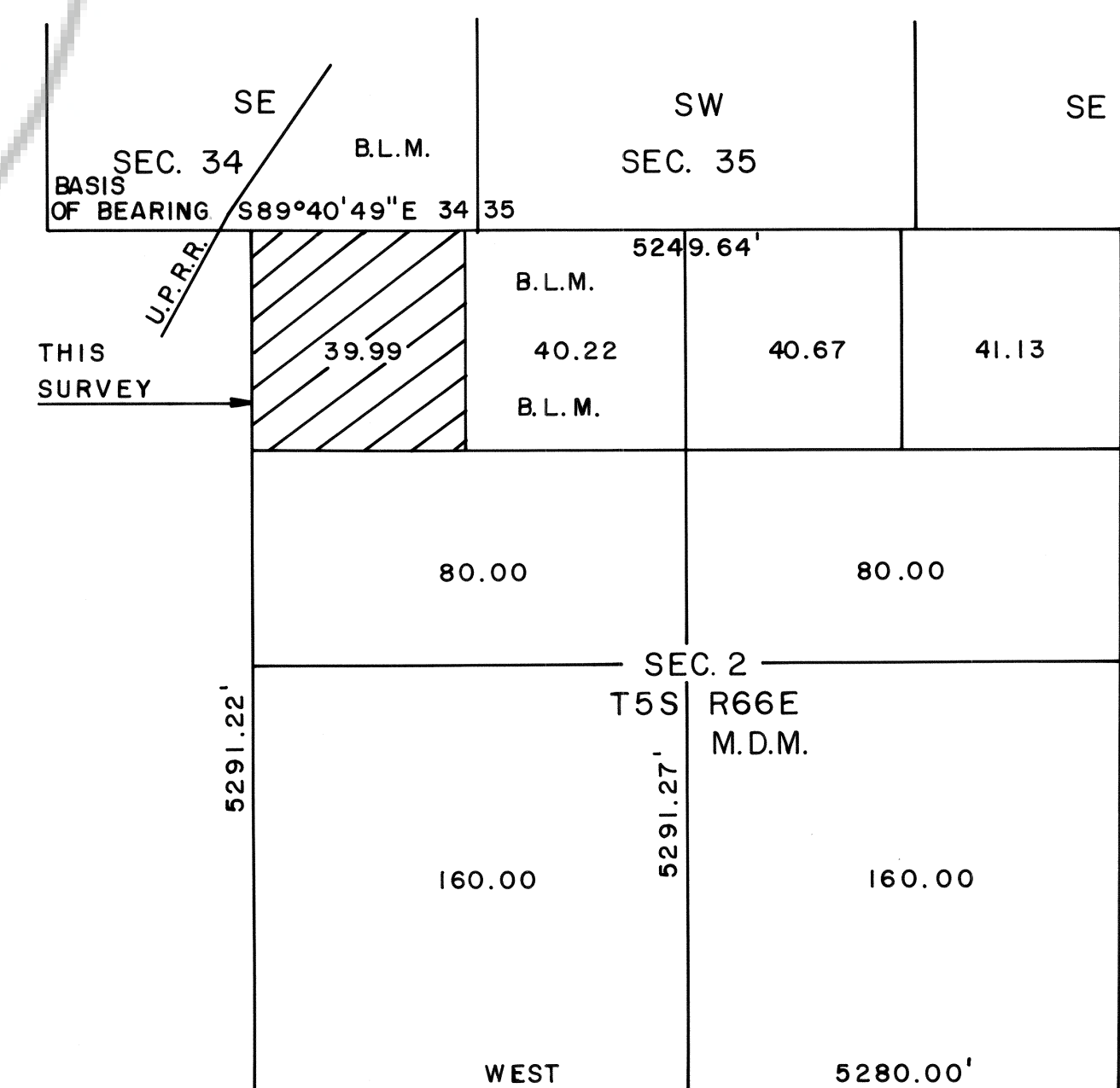

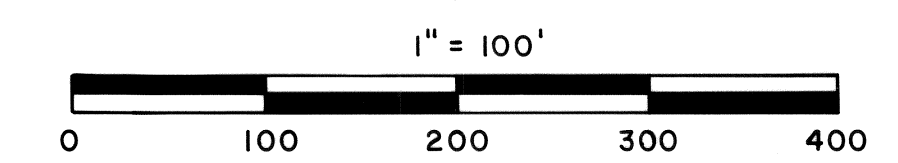


LEGEND:
