Short Form Deed of Trust and Assignment of Rents

This Deed of Trust, made this 10th day of February 1995, between

Carl Gartrell and Roxanne Gartrell, husband and wife as joint tenants,

whose address is PO BOX 422, Pioche, Nevada 89043, herein called TRUSTOR,

UNITED TITLE AGENCY OF NEVADA, INC., a Nevada Corporation, herein called TRUSTEE, UNITED TITLE and Nevada Bank & Trust Company herein call BENEFICIARY.

Witnesseth: That Trustor IRREVOCABLY GRANTS, TRANSFERS AND ASSIGNS to TRUSTEE IN TRUST, WITH POWER OF SALE, that property in Lincoln County, Nevada described as:

The East Forty-Five (45) Feet of Lot Four (4) in block Fourteen (14) in the town of Pioche, Nevada, as said lot and block are delineated on the Pioche Mines Consolidated, Inc., supplement "B" to the official map of the town of Pioche, County of Lincoln, State of Nevada.

TOGETHER WITH all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appurtenant. TOGETHER WITH the rents, issues and profits thereof, reserving the right to collect and use the same except during continuance of some default hereunder and during continuance of such default authorizing Beneficiary to collect and enforce the same by any lawful means in the name of any party hereto.

FOR THE PURPOSE OF SECURING: 1. Performance of each agreement of Trustor incorporated by reference or contained herein. 2. Payment of the indebtedness evidenced by one promissory note of even date herewith, and any extension or renewal thereof, in the principal sum of \$ 19,554.21 executed by Trustor in favor of Beneficiary or order. 3. Payment of such additional sums as may hereafter be advanced for the account of Trustor or Assigns by Beneficiary with interest thereon.

TO PROTECT THE SECURITY OF THIS DEED OF TRUST, TRUSTOR AGREES: By the execution and delivery of this Deed of Trust and the note secured hereby, that provisions (1) to (16) inclusive of the Deed of Trust recorded in the Book and at the page of Document No. of Official Records in the Office of the County Recorder of the county where said property is located, noted below opposite the name of such county, viz.:

(which provisions, identical in all counties, are printed on the reverse hereof) hereby are adopted and incorporated herein and made a part hereof as fully as though set forth herein at length; that he will observe and perform said provisions; and that the references to property, obligations, and parties in said provisions shall be construed to refer to the property, obligations, and parties set forth in the Deed of Trust.

The parties agree that with respect to provision 16, the amount of fire insurance required by covenant 2 shall be \$ 36,000 and with respect to attorneys' fees provided for by covenant 7 the percentage shall be 20.0 %.
