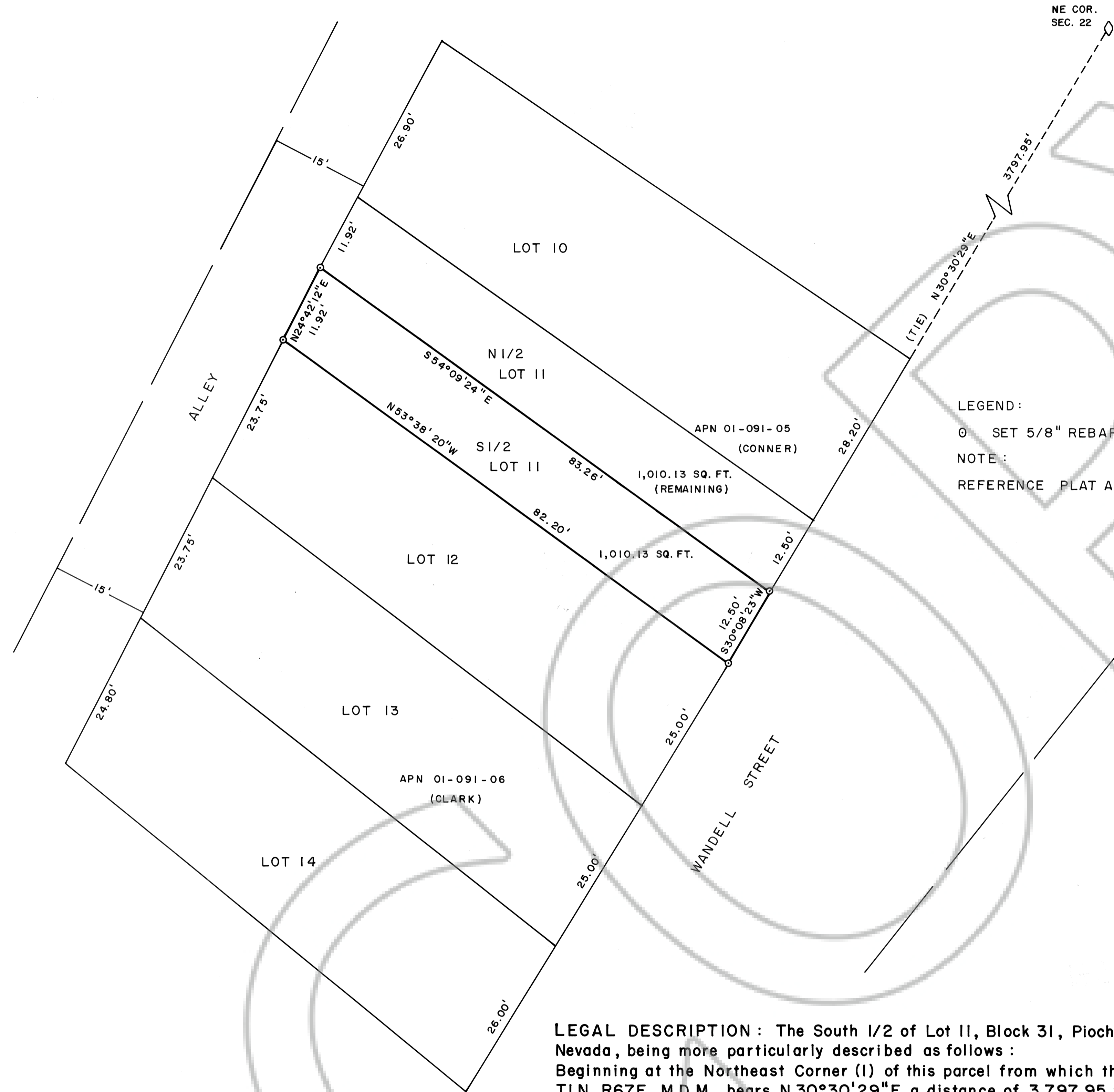


A PORTION OF BLOCK 31 PIOCHE TOWNSITE

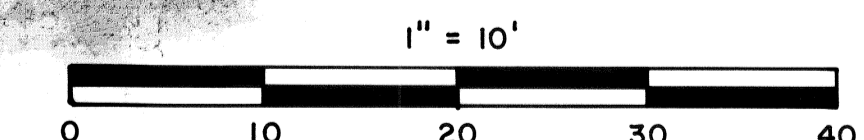
