**NOTICE AND DEMAND TO THE PRESIDENT OF THE UNITED STATES OF AMERICA
A SUPPLEMENT TO RESCISSION OF KNOWN STATUTORY FRANCHISES**

TO: THE UNITED STATES OF AMERICA, OFFICE OF PRESIDENT:

Enclosed herewith please find several verified documents entitled as follows:

1. These documents were not executed by me for light or transient reasons, and a sound respect for the opinions of the posterity of "We the People," whom your office was intended to represent as Chief Executive, compels me to put your office on notice, hereby, as follows:

2. It is clear from the history of America's settlement that America was intended to be a place for regathering the dispersed tribes of the white (nation) race. It is equally clear from the organic utterances of our white Christian forefathers, such as The Declaration of Independence, The Pledge of Allegiance, Statutes enacted by Congress in the first session and those enacted up to the year 1860, The Articles of Confederation, the original Constitution for the United States of America, and the original constitutions of the several states united, ad infinitum, were "ordained" and "established" to effectuate the continued regathering for the dispersed tribes of the White nation unto Christianity and America. This is our national heritage and purpose.

3. Also, to this end were the separate sovereignties established in each of the several states for local government of the people of each given state with a central government established only for the purpose of settling disputes between the several states, their citizens, and the citizens, subjects or inhabitants of foreign states, and for the purpose of uniting the several states and the people therein, for their mutual protection from foreign aggression and their mutual action in foreign policy.

4. I have recently discovered that this is no longer the design of our society, which has impelled me to discover the causes which have effectively converted our lawful and rightful society, a Constitutional Representative Republic, into a socialist-communist society combining the forms of Ochlocracy, Oligarchy, and Demagogy. I have discovered, as the office of president may already know, that immediately previous to, during and after the civil war factions crept into our government, which since have continually designed to prevent the effectiveness of our Constitutional Representative Republic(s) and to prevent the regathering of the "posterity." In this design, two elements are most prevalent: the derogation and destruction to state sovereignty and the derogation and destruction to the lawful status of the posterity composing the several states regathered here in America.

5. Congress has offered to the several states, and the citizens therein, statutory boon(s), benefit(s), and franchise(s), through statutes of a private nature, disguised as public law, to effectively usurp the authority of the several states and their citizens. The office of president and the Offices of the judiciary have been used with complicity to accomplish the end of this usurpations and tyrannical design. The above listed documents are my notice to those agencies I have discovered are a part of America and that they or their "posterity" established in the State of Utah.

6. Through statutory law schemes of a private law nature, Congress has usurped the limitations inherent to its powers pursuant to the supposed voluntary, implied, and direct consent of the American "posterity."

7. Congress has created many agencies by codified statutes, previously unknown to American law, and has vested statutory agents, their employees, officers, assigns and affiliates with a supposed authority to enter particular statutory agreements with other statutory and artificial entities and, finally, with members of the posterity, consistent with the design to make all the subject of Congressional legislation and internal legislative jurisdiction.

8. Through abuses of its legislative powers, the acquiescence of the several state governments and their unknowing citizens in the several states, Congress has created a new society, composed of public statutory entities, which recognizes no state citizen as such, and which recognizes no state as such, delineated in the original Constitution for the United States of America. Such a conversion is not authorized to Congress under any scheme and depends solely on the implied and direct consent of the American posterity obtained by fraud, deception, coercion, and misrepresentation.

9. I, Bryan E. Romney, hereby put the office of president of the united States of America on notice, that I am a member of the "posterity" and the original society entered into by my nation "We the People," that I am not a member of the new statutory society created by Congress' unauthorized conversions, and that I owe allegiance only to that original society and the organic laws they "Ordained" and "Established" in the united States of America and that they or their "posterity" established in the State of Utah.

10. Since the office of president, as chief executive, has been and is being used as an integral part of the statutory scheme to overthrow the rightful sovereign authority of the posterity to regulate their own society by organic law, it can logically be presumed that the records and other information available to the office of president reveal many more of the agents, officers, employees, assigns and affiliates involved that I as a citizen in the State of Utah can ferret out. Therefore, the duty of the office of president under the original Constitution for the united States of America to faithfully execute the laws, which includes making sure codified statutes are executed only on those within their scope and jurisdiction, is hereby invoked to prevent such agencies, officers, employees, assigns or affiliates from further attempting to force my membership in Congress' new and unauthorized statutory society.

11. WHEREFORE, I, Bryan E. Romney, by authority invested in me at my birth, by my Father in Heaven, as a member of the Christian Posterity, hereby demand the immediate end to the deceitful conduct and false witness, born to or against Him and His inheritance the posterity, the white nation in America; and,

12. I, Bryan E. Romney, hereby demand that the office of president discover, proclaim, and put into effect, the will of our Father in Heaven, regardless of the apparent cost to self or the public; and,

13. I, Bryan E. Romney, hereby demand a presidential proclamation for national awakening of the "posterity" to the Word of our Father in Heaven and the entirety of our national heritage; and,


14. I, Bryan E. Romney, hereby demand the restoration of the "posterity" to their Original society as the only society, body politic and citizenry in the united States of America; and,

15. I, Bryan E. Romney, hereby demand a presidential proclamation withdrawing the sanction of the high office of president from the aforementioned usurpations which threaten to ultimately destroy the society and nation of the "posterity"; and,

16. I, Bryan E. Romney, hereby demand that the office of president, as chief executive officer, issue a proclamation to all relevant statutory agents, officers and employees and their affiliates or assigns to cease and desist in their interaction with me, including but not limited to closing and sealing of any file they might hold pertaining to my life, liberty or property; and,


