

# Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 750 feet is claimed in a E/W direction and 750 feet in a W/E direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the EAST to the WEST.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by scribing the wood post - on the top of each post

- Corner No. 4 is a 4 inch wood post - scribing NW-CORNER - Red Land No. 1
- Corner No. 5 is a 4 inch wood post - scribing N-side-center - Red Land No. 1
- Corner No. 6 is a 4 inch wood post - scribing NE CORNER - Red Land No. 1

The monumentation and marking of the corners was completed by the 7 day of MAY, 1995.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
