

DECLARATION OF HOMESTEAD  
(Husband and Wife)

KNOW ALL MEN BY THESE PRESENTS: We, BRENTWOOD HEPWORTH and DOROTHEA DAWN HEPWORTH, do hereby declare:

- 1. THAT we are married persons (husband and wife); and, each own an interest in the land and dwelling premises collectively described below, and herewith selected as our declared homestead;
- 2. THAT we do now, at the date of recording this declaration reside with our family on the premises, and that it is our intention to use and claim the property as a homestead;

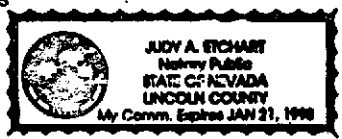
