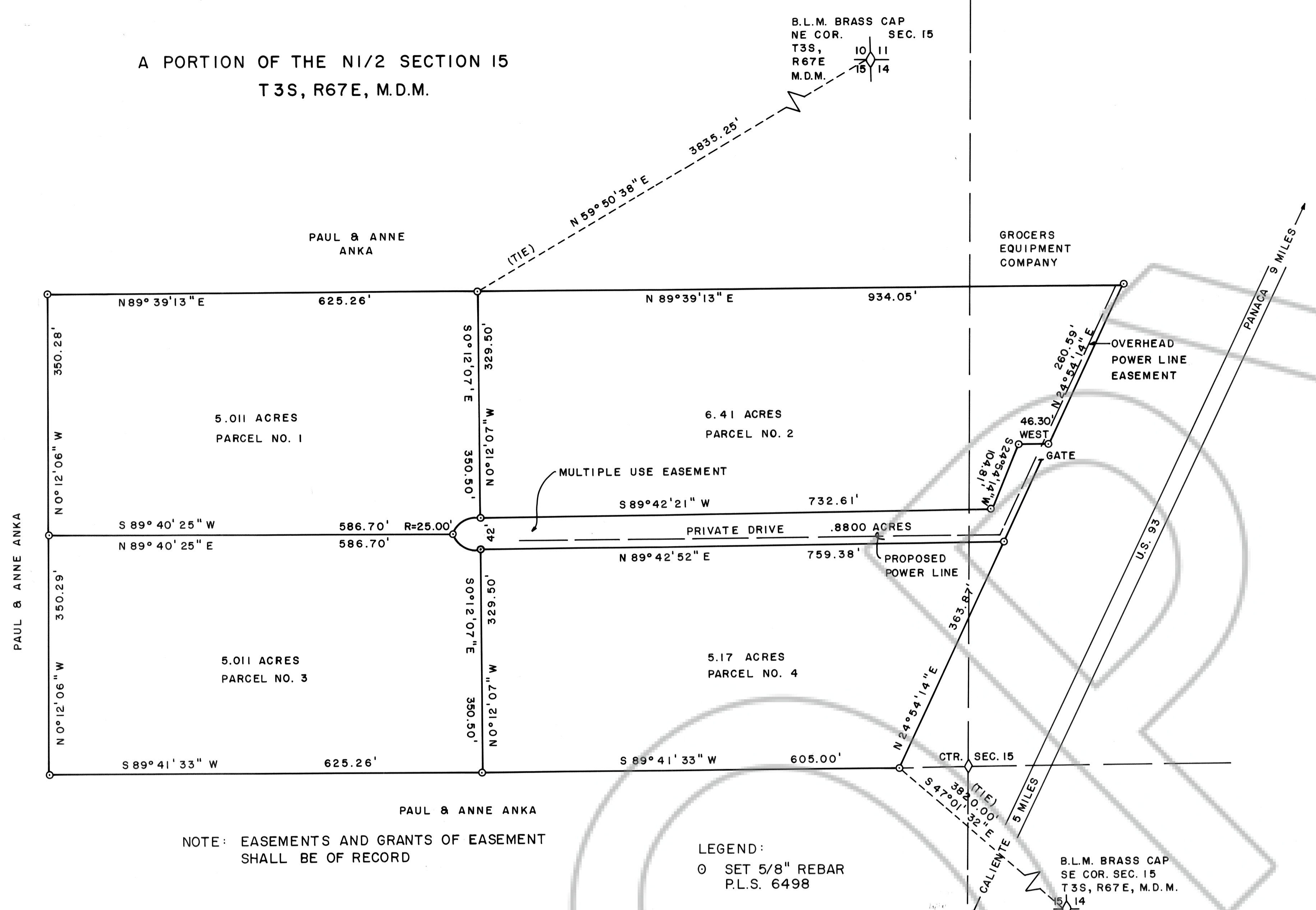


A PORTION OF THE N1/2 SECTION 15

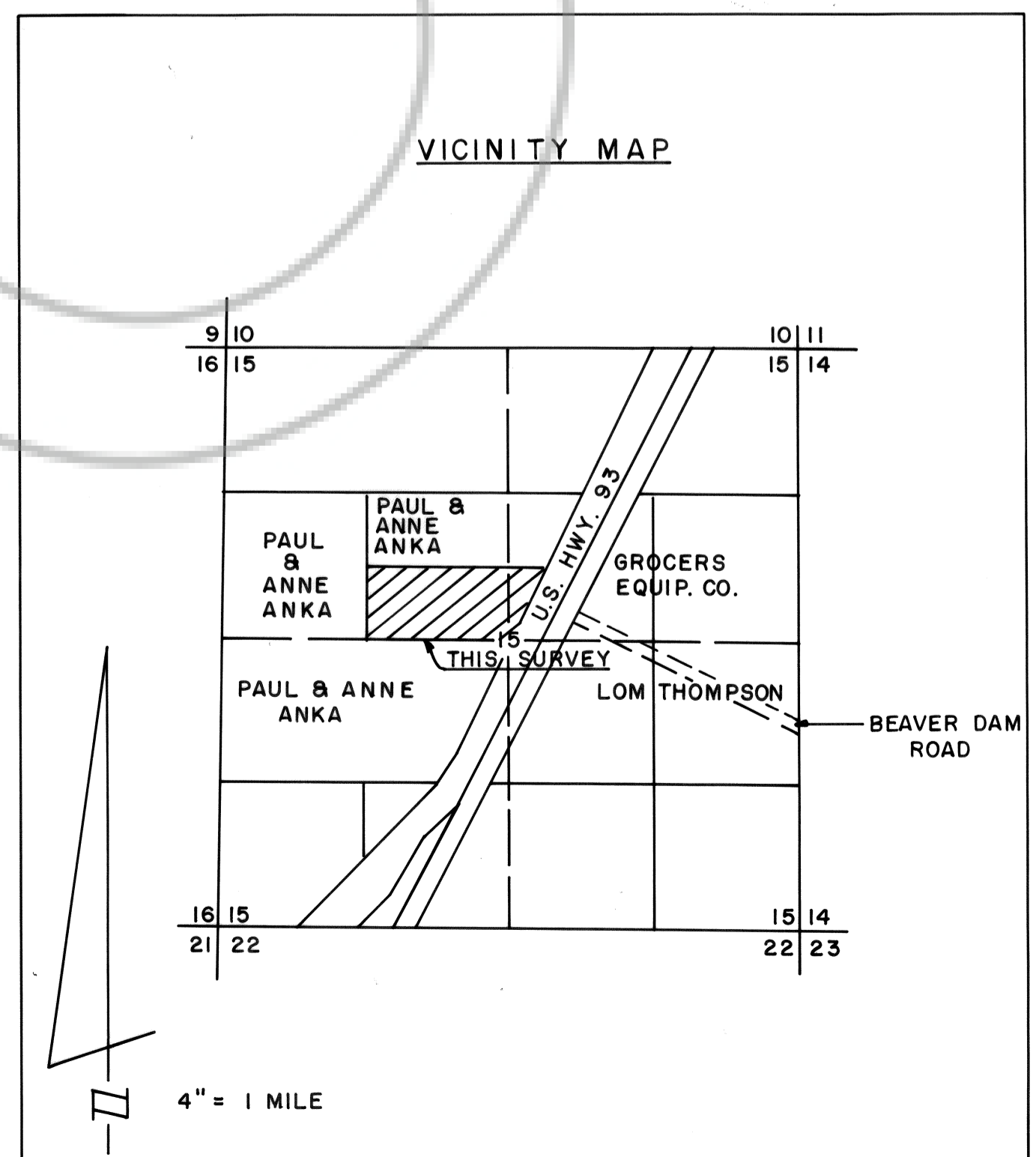

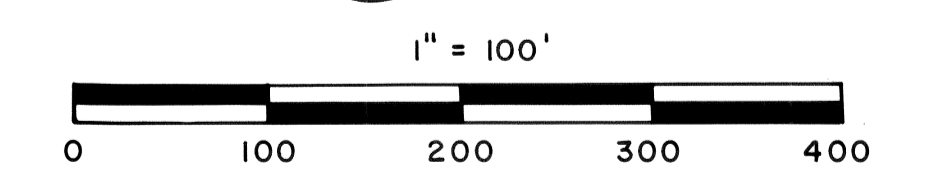
