

POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

That I, JOYCE HAMILTON, of Caliente, Nevada, hereby constitute and appoint ALICE LINDSAY, of Lexington, Kentucky, my true and lawful attorney in fact, for me and in my name, place and stead, giving and granting unto my said Attorney full power and authority to do and perform all and every act and thing whatsoever, requisite, necessary and proper to be done in and about the premises as fully, to all intents and purposes, as I might or could do if personally present, hereby ratifying and confirming all that my said Attorney shall lawfully do, or cause to be done, by virtue hereof.

Such power and authority herein granted includes, but not by way of limitation, the power and authority to make contracts, lease, sell or convey any real or personal property that I may now or hereafter own, to receive and receipt for any money which may now or hereafter be due to me, to draw, make and sign any and all checks, bill of exchange, contracts, or agreements, to invest or re-invest my money for me, to compromise in my behalf, settle, receipt and accept payment for, any claim for or against me, in whole or in part, to sign my name to checks on any bank account of mine, savings account, any safety deposit box or other similar receptacle owned by me, and to execute and deliver any and all papers for me and in my name that I myself could execute relating to my personal business and other business and to my personal and real estate, and to manage and control my personal and real estate.

This Power of Attorney shall be and is effective and irrevocable from the date of execution hereof and indefinitely into the future, and all persons may rely on the continuing validity of the Power of Attorney unless and until such time as such power shall have been formally canceled by written notice to any party relying on same and by written cancellation thereof duly recorded in the Office of the County Court Clerk of Lincoln County, Nevada.

This Power of Attorney shall continue to be valid and effective even if I become legally disabled or incompetent.




