KNOW ALL MEN BY THESE PRESENTS:

In consideration of the sum of Ten Dollars (\$10.00), and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Oaheyoh Two-Feathers, Grantor, does hereby remise, release and forever quit claim unto WAKINYAN HOLDINGS LIMITED, Grantee, and unto his heirs and assigns, all of its right, title and interest, claimed or held, in and to those certain mineral tailings located in Pioche, Nevada, Ely Mining District, Lincoln County, Nevada, more particularly described as :

Any and all rights to Placer Claims known as Plenty Coup I through III with the following legal description beginning at a point on the North edge of Pond 1 from the NE corner of Section 32, T1N, R67E, M.D.B. & Mbears N 88 09' 38" E a distance of 2549.87 feet, thus being the NorthEast Corner of Plenty Coup Claim I, thence Course 1 extend 600 feet to the West; thence along Course 2 in a Southerly direction for a distance of 4500 feet; thence along Course 3 in an Easterly direction for a distance of 600 feet; thence along Course 4 in a Northerly direction for a distance of 4500 feet. Plenty Coup I has the common border ending at the common barrier between Pond 4 and 5, Plenty Coup Claim II has the common border between Ponds 7 and 8. Plenty Coup Claim III has the common border between Ponds 9 and 10.
