DEED OF RECONVEYANCE



BEGINNING at a point 30 feet North and 40 feet West of the Southeast corner of Section 17, Township 2 South, Range 68 East, M. D.B. & M., and running thence North and parallel with the East line of said Section 17, a distance of 331 feet; thence running at right angles West for a distance of 647 feet; thence at right angles South 331 feet; thence at angles East a distance of 647 feet to the place of BEGINNING.

Said parcel of land is designated as Parcel No. 1 on the Parcel Map of the Southeast quarter (SE 1/4) of the Northeast quarter (NE 1/4) of Section 17, Township 2 South, Range 68 East, M. D. B. and M., which is on file in Book A of Plats at Page 167 in the Office of the County Recorder of Lincoln County, Nevada, and to which plat reference is hereby made for further particular description.

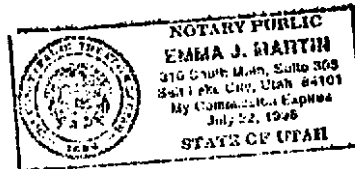
