CERTIFICATE OF LOCATION

ASARCO Incorporated, whose mailing address is 510 East Plumb Lane, Reno, Nevada, 89502, by its undersigned Agent, hereby certifies that it has located a mining claim in the Bristol Mining District, County of Lincoln, State of Nevada.

Located, dated and posted on this ground this 25 day of Sept, 1995.

The general course of said lode or vein as near as it may be described, is
north and south.

The discovery monument is located approximately 2020 feet, bearing N48°W from
SE corner, S36, T3N, R65E.

From this discovery monument, the undersigned claims 20 feet in a/an north direction, and, 1480 feet in a/an south direction, and, 300 feet on each side of the middle of the vein. The claim is 600 feet wide and 1500 feet long.

Surface boundaries of the claim are described as beginning at the discovery monument and running thence 20 feet in a/an north direction to the center of the north end line, and the true point of beginning, thence (clockwise)

300 feet in a/an east direction to corner no. 1, thence
1500 feet in a/an south direction to corner no. 2, thence
600 feet in a/an west direction to corner no. 3, thence
1500 feet in a/an north direction to corner no. 4, thence
300 feet to a/an east direction, the true point of beginning.

There are 5 wooden posts at least 1½"x1½"x4' set 1 foot in the ground, one for the discovery monument and one for each of the four corners as prescribed by NRS. 517.030. Each corner is marked by wooden post designating its appropriate corner number and/or location.

Location work for this mining claim consisted of preparing and filing a map of said claim as provided in NRS. 517.040.
