### CERTIFICATE OF LOCATION OF LODE MINING CLAIM STATE OF NEVADA, COUNTY OF LINCOLN

Said claim is a lode being situated in the above mentioned County and State, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" x 2" wooden posts with aluminum tag describing each corner, and is more particularly described as follows:
