CERTIFICATE OF LOCATION OF LODE MINING CLAIM STATE OF NEVADA, COUNTY OF LINCOLN

has located the LWH 21 Lode Mining claim on the 21 day of December, 1995 whose dimensions are 1500 feet by 600 feet. By this Declaration and such location, the above named locator(s) claim all veins, lodes, ledges, deposits and surface ground within the boundaries of said claim.

Said claim is a lode being situated in the above mentioned County and State, and it is distinctly marked on the ground so that its boundaries may be readily traced by four 2" x 2" wooden posts with aluminum tag describing each corner, and is more particularly described as follows:
