

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the TM-10 Lode Mining Claim in Unsurveyed Section(s) 13 Township 5 South, Range 65 East, M.D.M. and Unsurveyed Section(s) 18 Township 5 South, Range 66 East, M.D.M. in the DELAMAR Mining District, in Lincoln County, in the State of Nevada, on the November day of November, 1995.

The claim is 1500 feet long and 600 feet wide, and 20 feet is claimed in a westerly direction and 1400 feet in an easterly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the claim is from the west to the east.

The location and number of each corner of this claim is shown on the claim map filed herewith. On the ground, each corner of the claim is marked with its appropriate number by scribing on a metal tag affixed to a 2" x 2" x 5' wooden post.

The description of each corner is as follows:

- CORNER No. 1** (northeast corner) is a 2" x 2" x 5' wooden post or 1 1/2" x 1 1/2" metal fence post with description of corner scribed on metal tag affixed to post.
- CORNER No. 2** (southeast corner) is a 2" x 2" x 5' wooden post or 1 1/2" x 1 1/2" metal fence post with description of corner scribed on metal tag affixed to post.
- CORNER No. 3** (southwest corner) is a 2" x 2" x 5' wooden post or 1 1/2" x 1 1/2" metal fence post with description of corner scribed on metal tag affixed to post.
- CORNER No. 4** (northwest corner) is a 2" x 2" x 5' wooden post or 1 1/2" x 1 1/2" metal fence post with description of corner scribed on metal tag affixed to post.

The monumentation and marking of the corners was completed by the 13th day of November, 1995.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Lincoln County Recorder, and the lode claim filing fee has been paid to the County Recorder.
