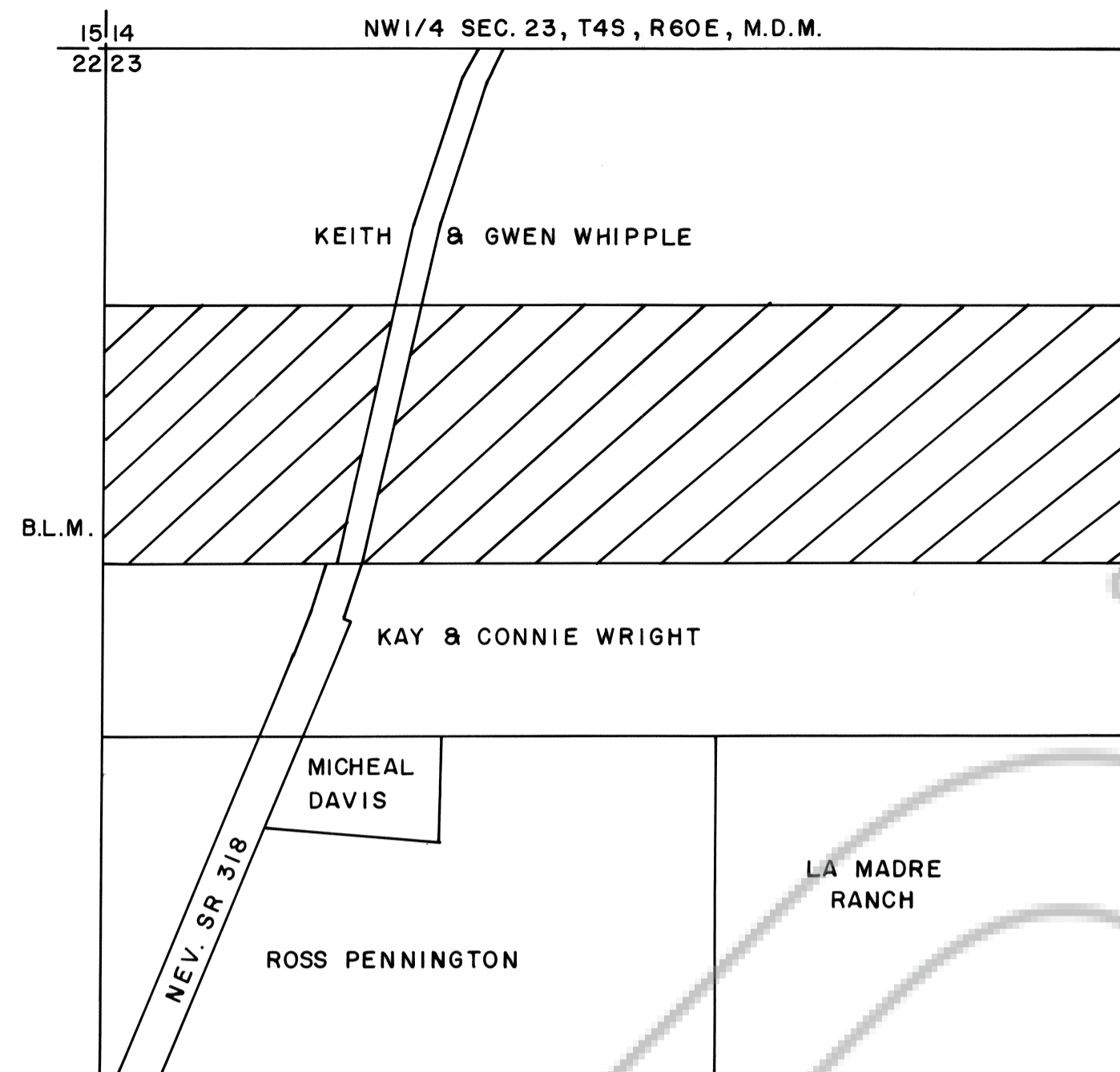
VICINITY MAP

SURVEYOR'S STATEMENT

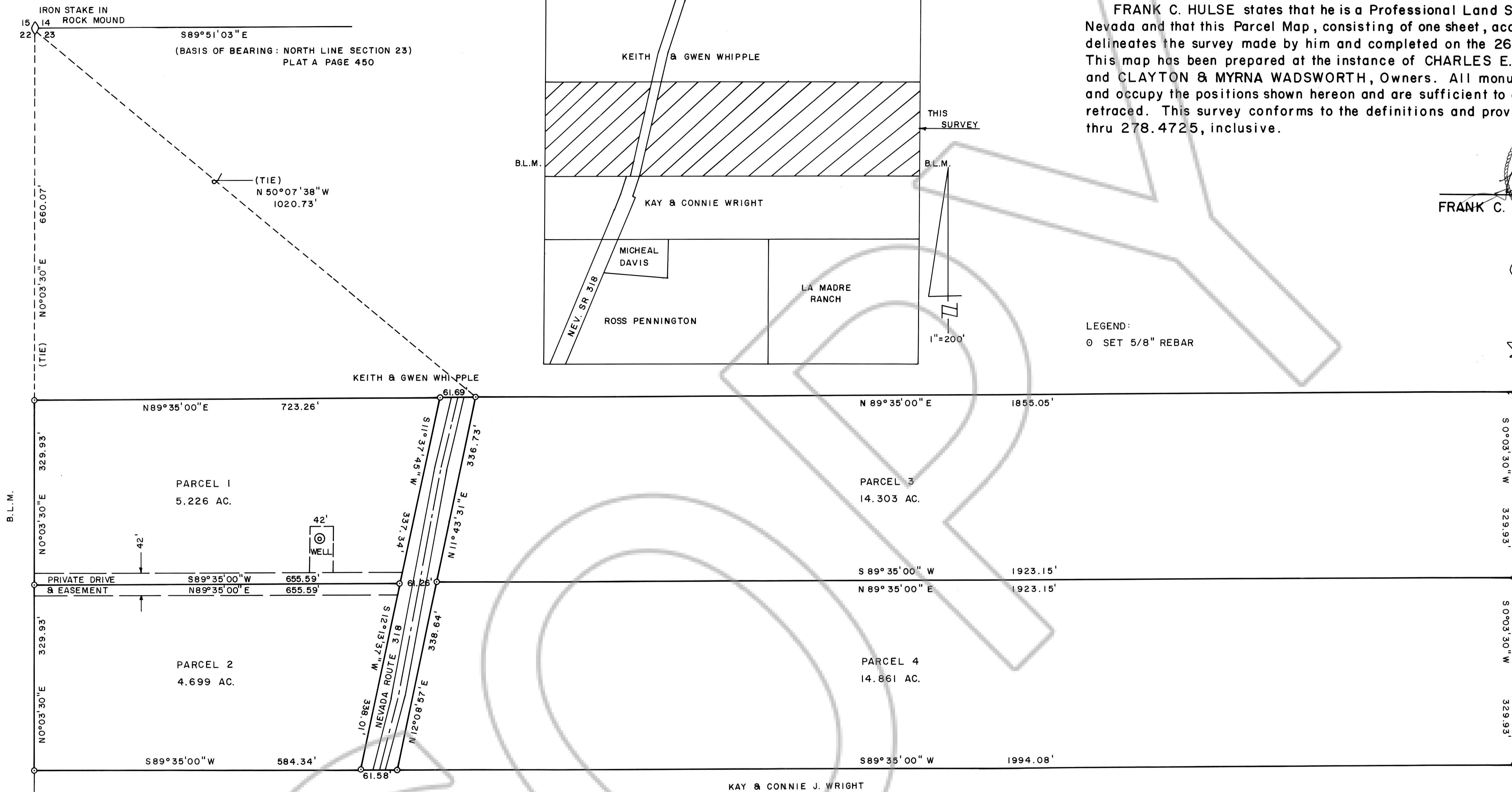

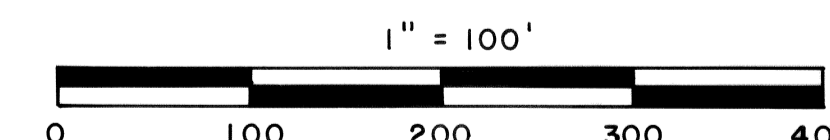
