


If said oil and gas lease covers less than the entire fee title, then the above overriding royalty interest shall be reduced proportionately.



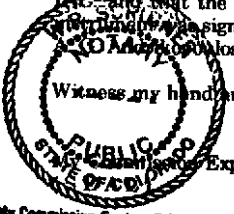

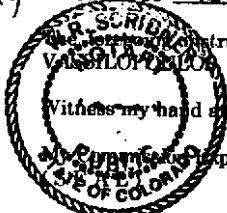
