James L. Wadsworth, Administrator with Will Annexed of HILDA BRACKEN WILCOX, deceased, having rendered and filed herein a full account and report of his administration of said estate, which account was for final settlement, and having with said account filed a petition for fees and allowances and final distribution of said estate, and said account and petition having this day come on for hearing, and proof having been made to the court that due and proper notice has been given, the court finds;
