15 James L. Wadsworth, Administrator with Will Annexed of HILDA
16 BRACKEN WILCOX, deceased, having rendered and filed herein a full
17 account and report of his administration of said estate, which
18 account was for final settlement, and having with said account
19 filed a petition for fees and allowances and final distribution
20 of said estate, and said account and petition having this day
21 come on for hearing, and proof having been made to the court that
22 due and proper notice has been given, the court finds;

23 1. That the account of the former and deceased administrator
24 has been approved and accepted by previous order of this court.

25 2. That the present account of James L. Wadsworth is true
26 and correct in all particulars, and that it is supported by proper
27 vouchers or other proof; that the estate consisting of real prop-
28 erty and cash remaining in the hands of the administrator to be

1 distributed and for payment of fees, allowances and closing of
2 the estate is \$53,115.05, of which \$10,222.05 is cash in banks.

3 3. That all properly filed claims against the decedent and
4 the estate have been paid, all taxes have been paid and the es-
5 tate is now ready for distribution and to be closed.

6 4. That the statutory commission to the administrators of
7 said estate is \$1,857.90, of which one-half should be paid to
8 the representative of the deceased administrator, Dominick
9 Belingheri and one-half paid to James L. Wadsworth, and that the
10 negotiated attorney fees are \$3,540, which is hereby approved.

11 5. That under the terms and conditions of the last will
12 and testament of HILDA BRACKEN WILCOX, deceased, the daughters
13 of deceased, Roilene Wilcox Holbrook and Connie Rae Branson, were
14 to receive the residue of the estate, share and share alike;
15 however, Connie Rae Branson pre-deceased Hilda Bracken Wilcox,
16 leaving as her sole heirs two sons both of whom have signed and
17 filed their disclaimers in favor of Roilene Wilcox Holbrook who
18 thereby became the sole distributee entitled to the estate.

19 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

20 1. That the final account of said administrator with will
21 annexed including his estimate of \$35.00 for costs of closing
22 the estate be, and the same is hereby , finally settled, allowed
23 and approved;

24 2. That the sum of \$1,857.90, divided as aforesaid, for
25 and on account of commissions for administrators as allowed by
26 law, and the negotiated sum of \$3,540.00 as and for attorney fees
27 be, and they hereby are, allowed, authorized, and directed to be
28 paid; and

1 3. That the residue of the estate hereinafter particularly
2 described, and any other property not now known or discovered,
3 which may belong to the said estate or which the said estate may
4 have an interest in, be, and the same is hereby distributed to
5 Rollene W. Holbrook.

6 The following is the particular description of said residue
7 of said estate referred to in this decree, and of which distribu-
8 tion is now ordered as aforesaid:

9 Any personal property, furniture and appliances not already
10 in the hands of distributee;

11 The real estate described as the Northerly one-half of Lot
12 Seventeen (17) in the Henry Lee Subdivision of the Town of Pioche,
13 County of Lincoln, State of Nevada;

14 All cash in banks after the payment of the commissions, fees
15 and allowances approved herein amounting to \$4,789.15; and

16 4. On filing of the proper receipts showing full distribu-
17 tion and payment as aforesaid, the administrator is entitled to
18 be fully discharged.

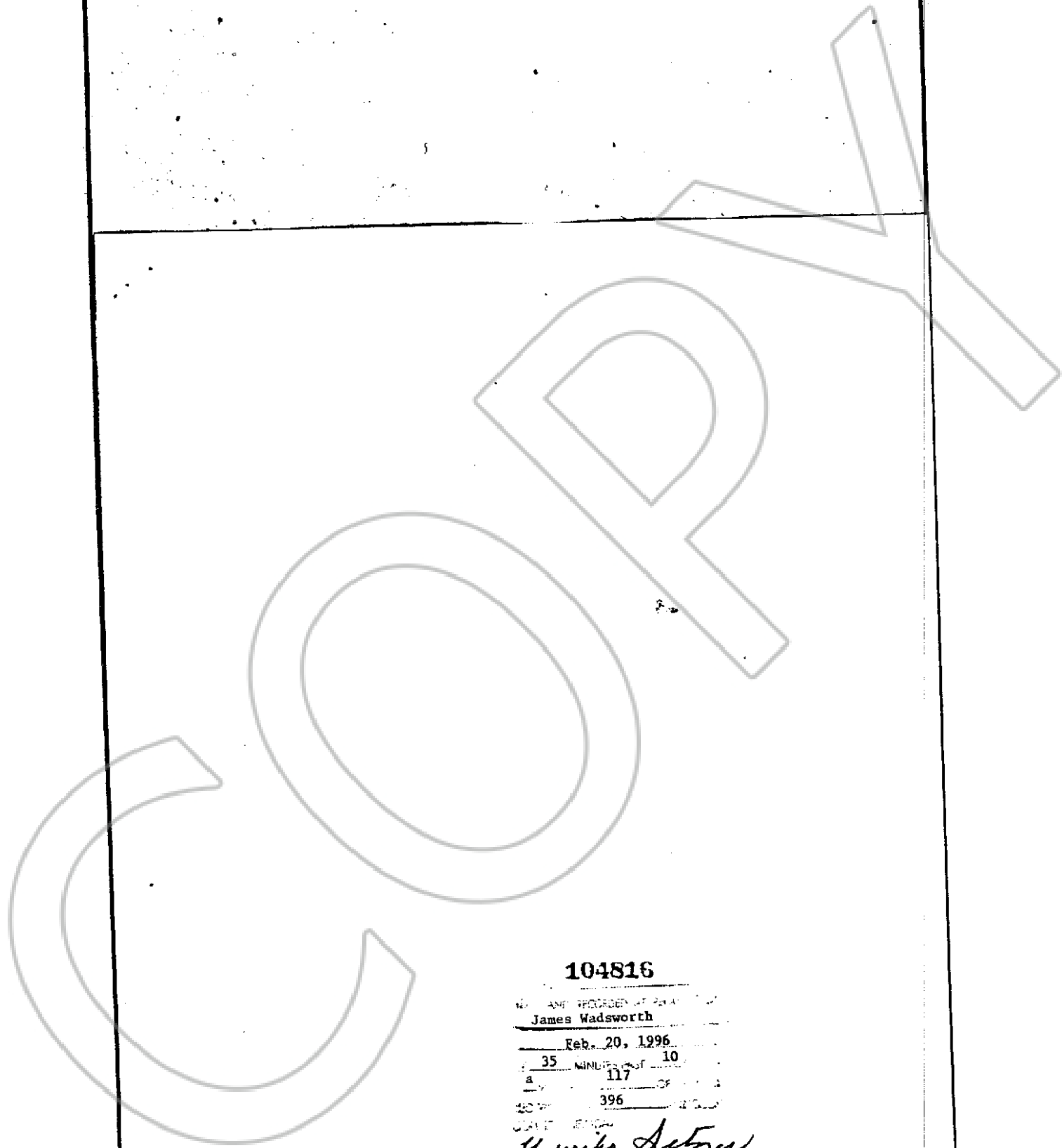
