IT IS HEREBY STIPULATED by and between the Plaintiff, Nevada Federal Credit Union, and the Defendants, Robert Donald Allison and Gladys Allison, as follows:

The Court may enter Judgment in favor of the Plaintiff in the principal amount of \$19,203.12, with prejudgment interest thereon of \$14,310.27, together with costs of \$713.00 and attorneys fees of \$2,000.00. This Judgment shall bear interest on the principal from date of entry at the rate of 16% per annum until paid in full except as otherwise provided herein.

2. In return for Plaintiff's agreement to forego immediate execution on said Judgment and to accept \$16,000.00 as satisfaction in full for the Judgment, Defendants shall be permitted to satisfy the Judgment by monthly installments as hereafter provided, time being of the essence; (a) the amount of \$16,000.00, plus annual interest at 7.5%, is payable at the rate of \$148.34 per month (amortized on a 15-year schedule) commencing on August 15, 1993 and continuing thereafter on the fifteenth day of each consecutive month, for a total of sixty (60) months, with the remaining balance of \$12,496.00 due and payable on July 15, 1998; (b) there shall be a grace period of 30 calendar days for each required payment. In the event that Defendants fail to timely make any payment required, Plaintiff may, without notice, accelerate all payments required hereunder and call the entire amount of the Judgment (principal amount of \$19,203.12, prejudgment interest of \$14,310.27, together with post-judgment interest at 16% on said principal from entry of Judgment, costs of \$713.00 and attorney's fees of \$2,000.00) to be immediately due and payable with credit for past payments, and may enforce and execute upon said Judgment as against Defendants.
