# EXHIBIT "C"

# POWER OF ATTORNEY

## KNOW ALL MEN BY THESE PRESENTS:

1. That Max McCrosky, of Rose Valley, Town of Pioche, County of Lincoln State of Nevada, hereby appoints Shirley Higgins McCrosky of Rose Valley, Town of Pioche, County of Lincoln State of Nevada, my true and lawful power of attorney in fact from this date: July 15, 1994 and in Max McCrosky's name, place and stead and for Shirley Higgin's McCrosky's use and benefit:

(a) To exercise, do, or perform any act, right, power, duty, or obligation whatsoever that Shirley Higgins McCrosky now have or may acquire the legal right, power, or capacity to exercise, do, or perform in connection with, arising out of, or relating to any person, item, thing, transaction, business property, real or personal, tangible or intangible, or matter whatsoever;

(b) To ask, demand, sue for, recover, collect, receive, and hold and possess all such sums of money, debts, dues, bands, notes, checks, drafts, accounts, deposits, legacies, bequests devices, interests, dividends, stock certificates, certificates of deposit, annuities, pension and retirement benefits, insurance benefits and proceeds, documents of title, choses in action, personal and real property, intangible and tangible property and property rights, demands whatsoever, liquidated or unliquidated, as are now. Or shall hereafter become due, owing, payable, owned, or belonging to Max McCrosky or in which Max McCrosky have or may acquire an interest, and to have, use, and take all lawful ways and means legal and equitable remedies, procedures, writs in Max McCrosky 's name for the collection and recovery thereof, and to compromise, settle, and agree for the same, and to make, execute, and deliver for Max McCrosky and in Max McCrosky' name all indorsements, acquittances release, receipts, or other sufficient discharges for the same;

(c) To improve, repair, maintain, manage, insure, rent, lease, sell, release, convey, subject to liens, mortgage, and hypothecate, and in any way or manner deal with all or any part of any real or personal property, tangible and intangible, whatsoever, or any interest therein, which Max McCrosky now owns or may hereafter acquire, for Max McCrosky in Max

(e) To sign, indorse, execute, acknowledge, deliver, receive, and possess such applications, contracts agreements, options, covenants, deeds, conveyances, trust deeds, security agreements bills of sale, leases, mortgages, assignments, insurances policies, bills of lading, warehouse receipts, documents of title, bills, bonds, debentures, checks, drafts, bills of exchange, note, stock certificates, proxies, warrants, commercial paper, receipts, withdrawn receipts, and deposit instruments relating to accounts or deposits in or certificates of deposit of, banks, savings and loan or other institutions or associations, proofs of loss, evidence of debts, releases, and satisfaction of mortgages judgments, liens, security agreements, and other debts and obligations, and such other instruments in writing of whatever kind, and nature as may be necessary or proper in the exercise of the rights and powers herein granted.

Granting to Shirley Higgins McCrosky attorney in fact full power and authority to do and perform all and every act and thing whatsoever requisite, necessary, and proper to be done in the exercise of any of the rights and powers herein granted, as fully to all interests and purposes as Max McCrosky might or could do it personally present, with full power of substitution or revocation, hereby ratifying and confirming all that Shirley Higgins McCrosky in fact or his substitute or substitutes shall lawfully do or cause to be done by virtue of this power of attorney and the rights and powers herein granted.
- 3. This instrument is to be construed and interpreted as a general power of attorney. The enumeration of specific items, acts, rights or power herein does not limit or restrict and is not to be construed to interpreted as limiting or restricting the general powers herein granted to my attorney in fact.
