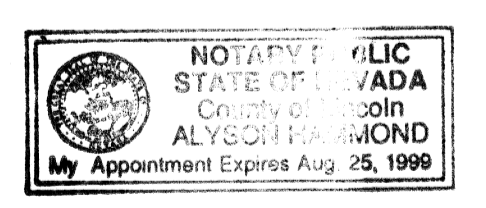

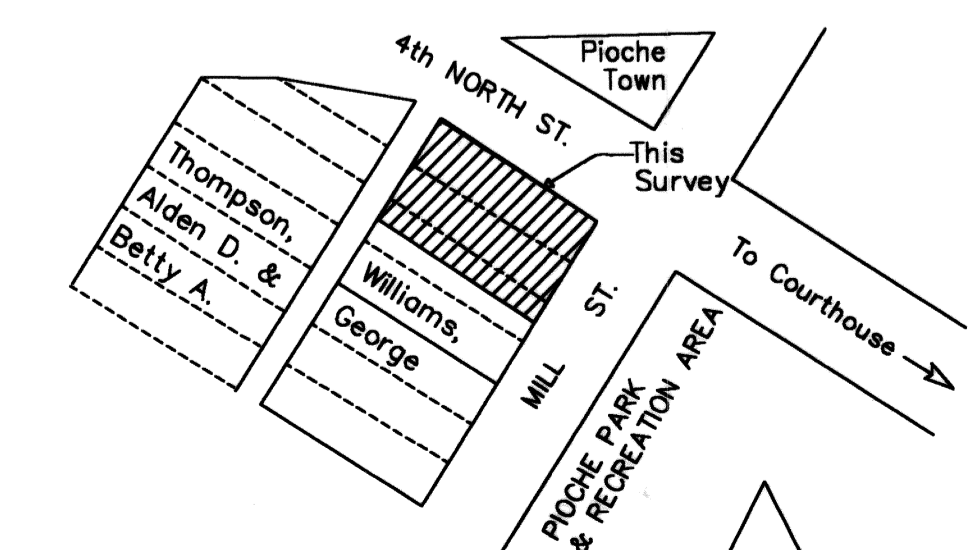

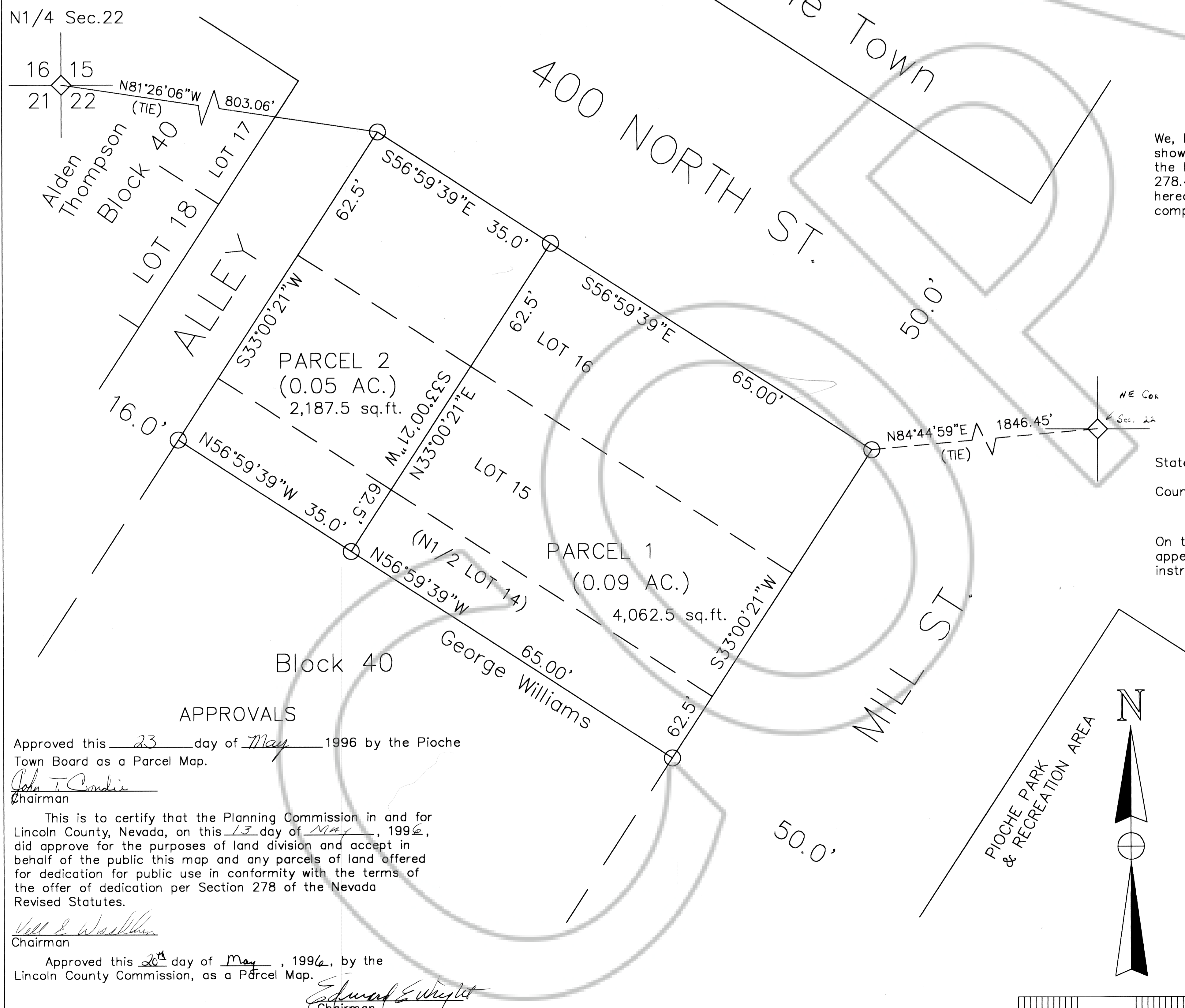
### Vicinity Map

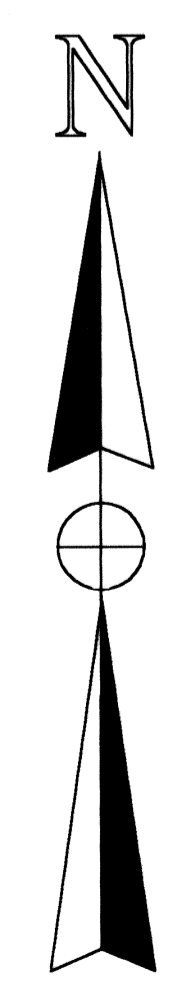
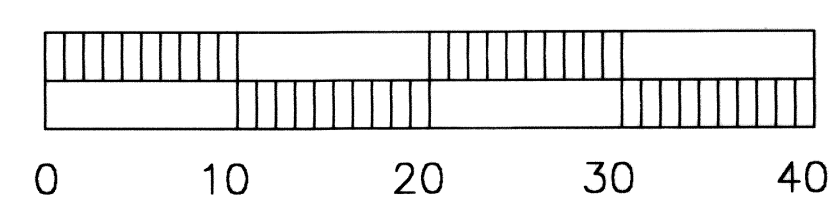
