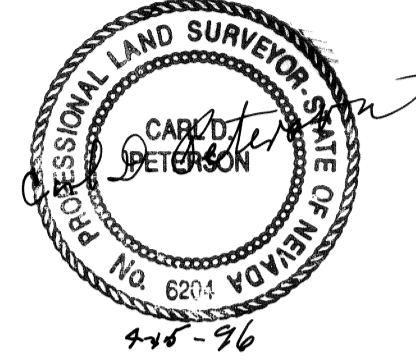


### SURVEYORS CERTIFICATE

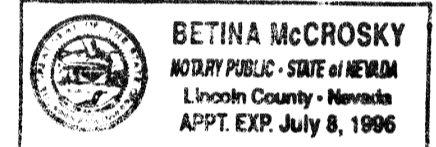

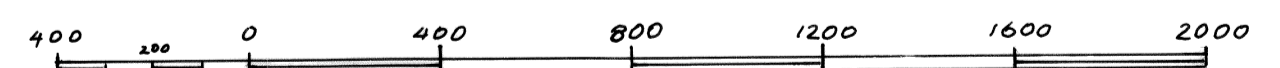

### BASIS OF BEARINGS

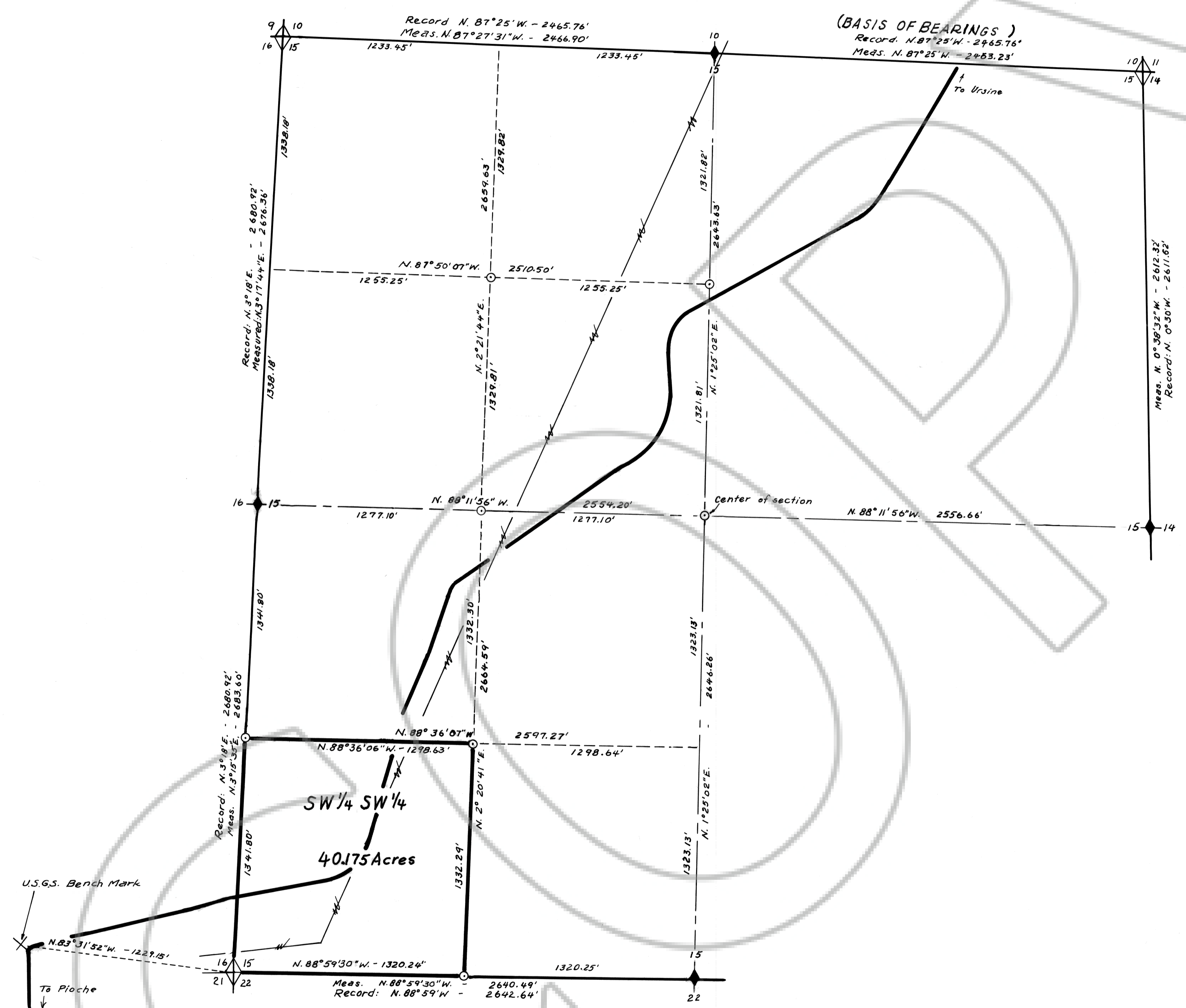
The north line of section 15, east of the north quarter corner recorded B.L.M. 1976 Dependent resurvey.
