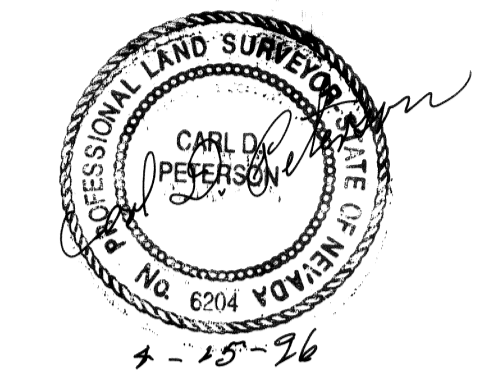


### SURVEYORS CERTIFICATE

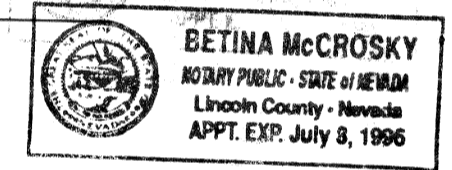

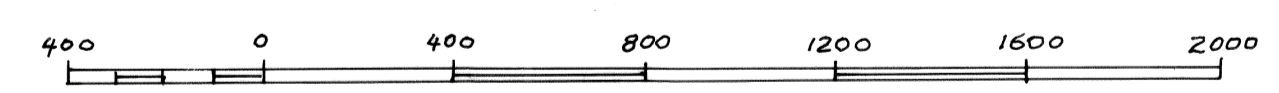

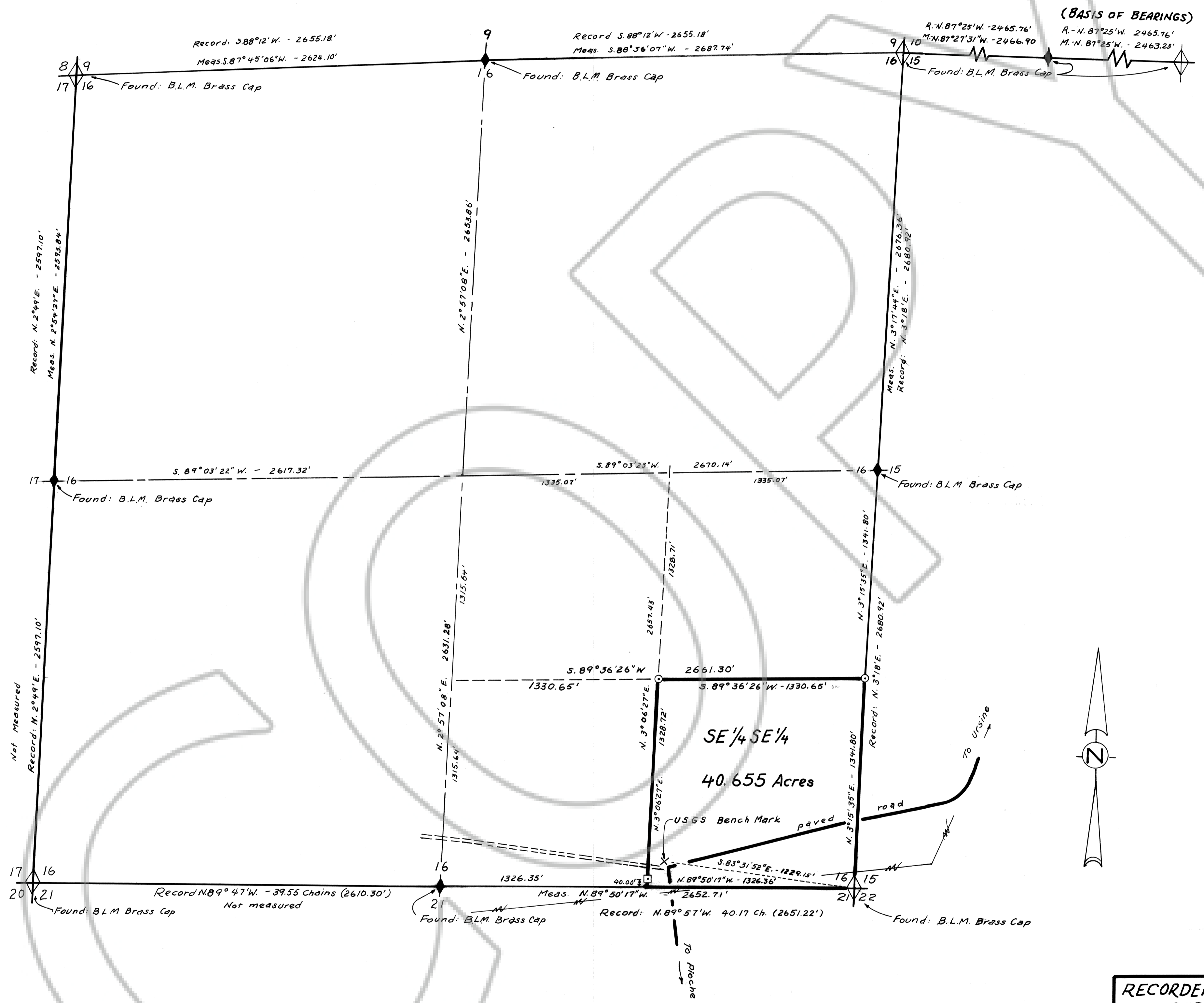
The north line of section 15, east of the north quarter corner recorded B.L.M. 1976 Dependant resurvey.
