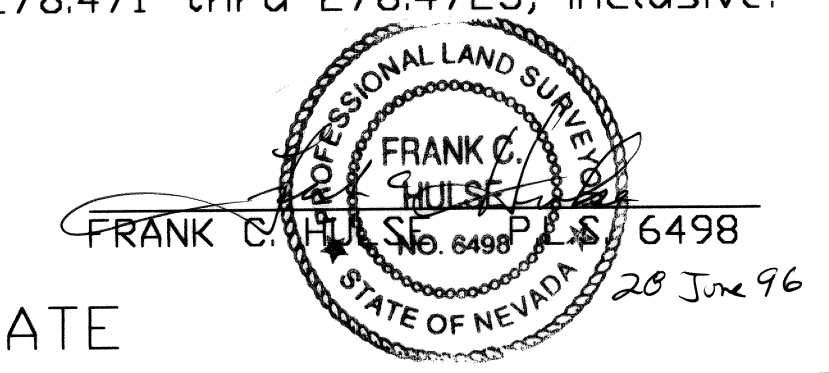


SURVEYOR'S STATEMENT

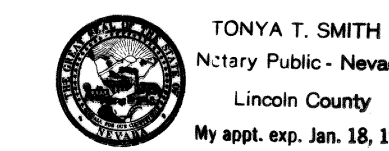

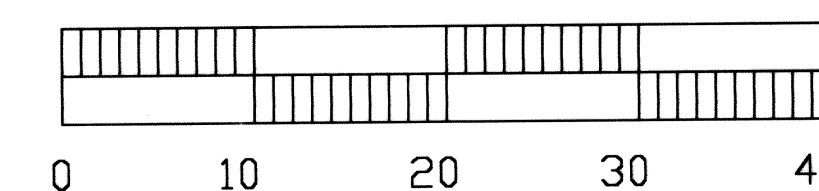

MAIN ST. N59°57'00"E

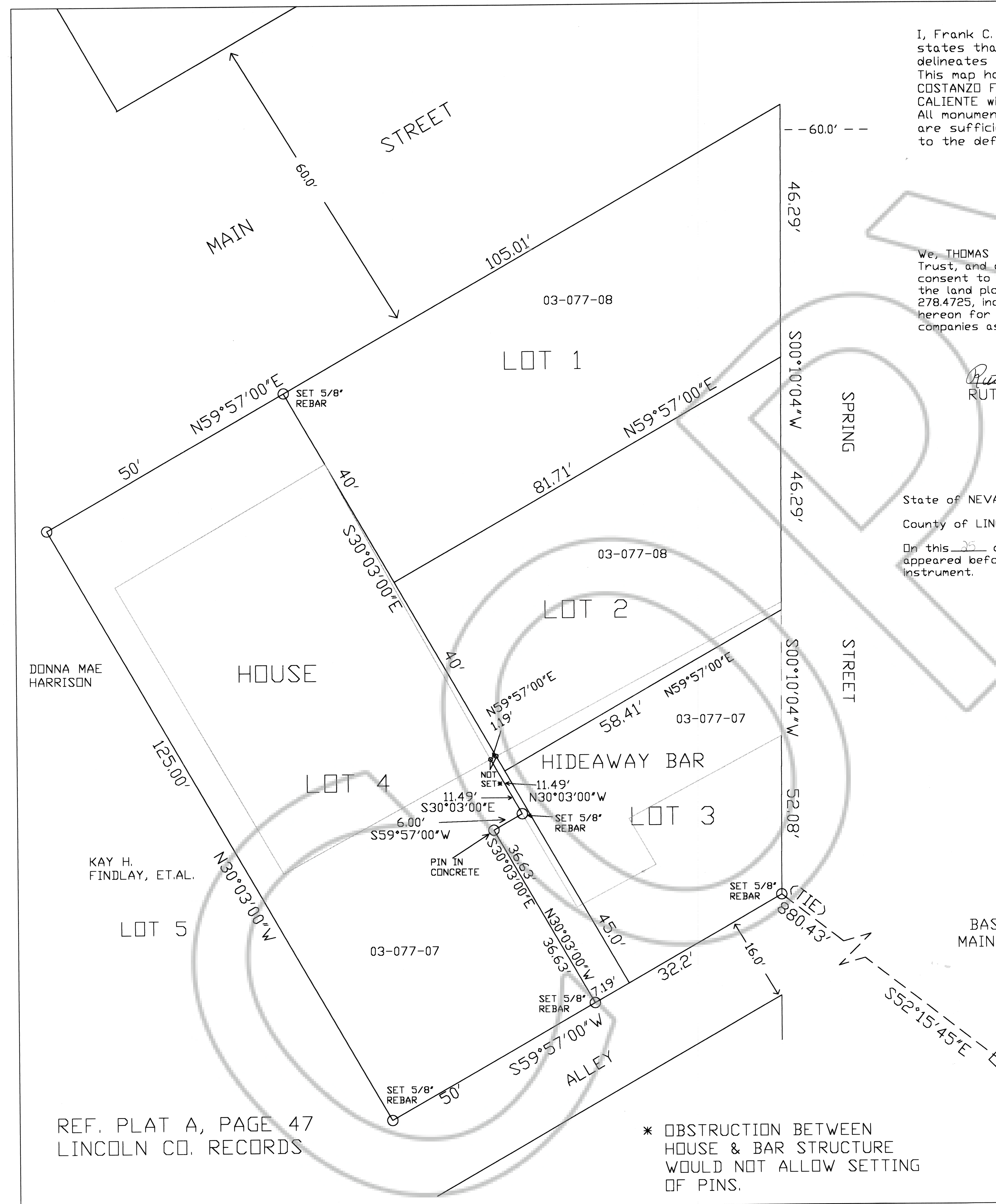
