BASIS OF BEARING

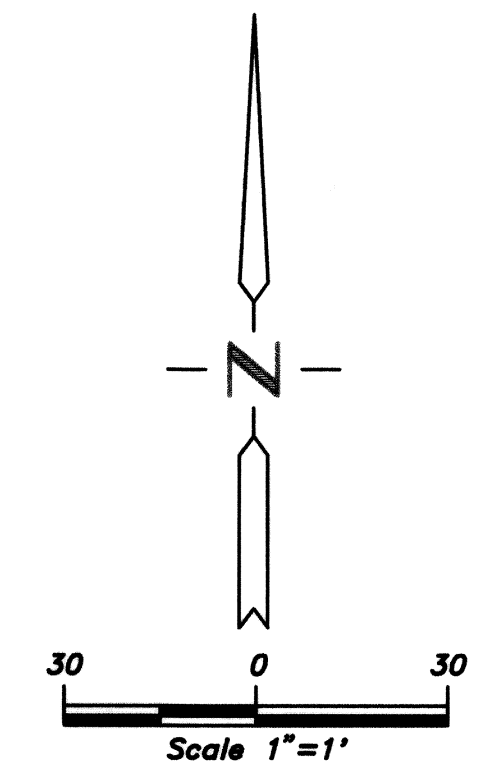


1. Town of Pioche Re-Survey Plat by Bulloch Bros. Engineering, Plat "A", Page 382-A.
