SURRENDER OF OIL AND GAS LEASE IN WHOLE

WHEREAS, Under date of December 1, 1991, the Secretary of the Interior of the United States, pursuant and subject to the terms and provisions of the Act of Congress, approved February 25, 1920 (41 Stat. 437), as amended, issued that certain Oil and Gas Lease bearing Serial Number N-55178 to D. M. Yates, recorded in Book 100, Page 465 of the records of Lincoln County, Nevada, and covering the following described lands situated in Lincoln County, Nevada, to-wit:

WHEREAS, Hunt Oil Company of Nevada, 1445 Ross at Field, Dallas, Texas 75202, and Winn Exploration Co. 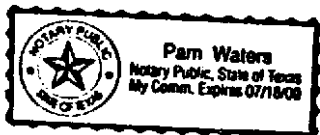

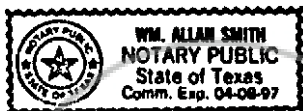
